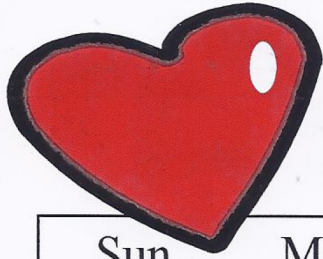





Lake Santee Members

On behalf of the Lake Santee Property Owners Association Board of Directors and Staff we would like to take this opportunity to inform you of our 2015/2016 budget forecasts.

The 2015/2016 budget forecast addresses a number of challenges that the Association faces to continue work on numerous capital improvement projects. During the past several years the Board and Staff have worked to improve our aging infrastructure by replacing our north bridge, remodeling our community building including replacing the heating and cooling systems, replacing our beach playground equipment and starting a lake dredging project. Many of these projects were funded through reserve funds that had been accumulated over the past years and generous donations from various sources.

This season the Association will not dredge as we have in the past 2 seasons. Instead we will set up a reserve account to fund the dredging project on an every other year basis.

The Association has tested various processes to improve our gravel roads and have determined that chip/seal and using geo/tech material on trouble spots is a very viable way to move forward. The 2015/2016 budget has been adjusted to continue those improvements. The plan would be in addition to normal every other year scheduled paving of Santee Drive, an additional section of gravel road would get chip/seal.

Another major project that will be addressed this season is the relining of the dam spillway culvert. This project must be done to make sure the integrity of the spillway is kept intact.

The Association is also challenged with the task of controlling the nutrient levels that come into the lake from the surrounding farming areas.

Lastly, the association needs to rebuild contingency funds for emergencies and future projects. The 2015/2016 budget addressed that as well.

The 2015/2016 budget includes a dues/assessment increase of \$25.00. No other fees will be increased. The Board and Staff do not take this action lightly and will continue to work very diligently to use the funds we receive from you in a very prudent manner.

It's a privilege to serve you, the residents of Lake Santee. We encourage constructive comments and welcome all to attend monthly board meetings held the 2<sup>nd</sup> Wednesday of every month at 7:30PM in the community room.

## Deadline for 2015 Dues and Assessments is April 1st

Statements for the 2015 Dues and Assessments will be mailed out on February 10<sup>th</sup>, are due March 1<sup>st</sup>, & past due April 2<sup>nd</sup>. The amount for 2015 will be \$620.00 (\$25 Dues & \$595 Assessment) & \$62.00 for each additional lot. This is a \$25 increase in assessments. Payment must be received in the office before April 2<sup>nd</sup> to avoid a 10% penalty. A monthly finance charge of 1 ½ % is charged on all outstanding balances. Boat permits & golf carts are the same as last year. Boats with a motor are \$50 & all others are \$15. Golf carts are \$20 but night operation golf carts will require inspection before the new permits are issued. If you mail in your payments, permits & passes will be returned by mail except for the night operation golf cart permits.

## LAKE SANTEE

### PROPERTY OWNERS ASSOCIATION TEAM BASS TOURNAMENTS

#### Official Rules

1. All Lake Santee rules and bylaws will be followed.
2. There will be a mandatory meeting FIFTEEN (15) minutes prior to the start of the tournament at the Lake Santee Main Beach Shelter. Those teams not entered prior to the meeting will be disqualified unless prior arrangements have been made with tournament official(s).
3. Boat positions will be determined at the mandatory meeting by a number draw.  
The start will be a continual "ooze off" of boats by the position drawn.
4. A mandatory boat check will be conducted prior to the start of the tournament.  
*All boats must be equipped with an aerated livewell capable of sustaining a limit of bass.*
5. Safe boating must be observed at all times. Each participant is required to wear a USCG approved life preserver and the kill switch should be working properly any time the combustion engine is in operation prior to and during tournament hours.
6. Only largemouth, smallmouth, and spotted (Kentucky) will be counted towards the daily limit of five (5) bass per team. Only artificial baits may be utilized in competition, including pork type trailers.
7. Only bass measuring sixteen (16) inches or longer will be weighed. The official board will be the Golden Rule. No short fish will be counted towards daily limit. The penalty for weighing short fish will be the weight of short fish plus two (2) ounces per fish deducted from the total of the legal fish that are weighed in.
8. No dead bass will be counted. *All bass must be released in healthy condition. Any bass which fails to swim away upon release will be scored as a dead fish and the weight of that fish plus eight (8) ounces will be deducted from that teams' remaining weight.*
9. Participants will not be allowed to leave the boat during tournament hours. Participants may briefly leave the boat for an exigent emergency or answer the "call of nature".
10. All ties will be determined by combining the prizes and dividing it equally between the respective teams. All protests must be made in writing within **TEN (10)** minutes of tournament conclusion.
11. No cheating will be tolerated and contestants may only use artificial baits during competition.
12. Competitors are expected to follow a high standard of sportsmanship, safety, and conservation. Alcohol and abused drugs will not be consumed during tournament hours.
13. The Tournament will be a two (2) man team style format. At least one member of each team must be an L.S.P.O.A. member in good standing. Members may fish alone and be considered a team.

1/2 cup sugar

1 egg yolk  
1 1/2 cups all purpose flour

2 tbsp. raspberry or strawberry preserves  
confectioners' sugar, optional

### Directions:

1. In a bowl, cream butter and sugar. Add egg yolk; mix well. Stir in the flour by hand. On a lightly floured surface, gently knead dough for 2-3 minutes or until thoroughly combined.
2. Roll into 1 inch balls. Place 2 inches apart on greased baking sheets. Using the end of a wooden spoon handle, make an indentation in the center of each. Fill each with 1/4 teaspoon preserves.
3. Bake at 350° for 13-15 minutes or until edges are lightly browned. Remove to wire racks. Dust warm cookies with confectioners' sugar if desired. Cool. Yield: about 2 dozen.

The brutal weather abated for January 16-19, our bird count days, so our feeders were not as busy as might have been. Nevertheless we had a good count and enjoyed chili and pie to celebrate the tally on Monday evening. With many snow birds in Florida, this year we seven counters, Deb Evans, Kim Belter, Betty Gabbard, Fae Cutrufelli, Carol Reger, Charm Seright, and Nancy Fredrickson achieved the following results:

Canada Geese 455, Mute Swan 6, Mallard 57, Hooded Merganser 16, Odd ducks 6, Blue Heron 3, Turkey Vulture 37, Cooper's Hawk 1, Bald Eagle 3, Ring Billed Gull 10, Mourning Dove 6, Red Headed Woodpecker 1, Red-bellied Woodpecker 6, Yellow-bellied Sapsucker 1, Downy Woodpecker 12, Hairy Woodpecker 3, Northern Flicker 2, Pileated Woodpecker 4, Blue Jay 13, American Crow 11, Carolina Chickadee 12, Tufted Titmouse 11, White-breasted Nuthatch 10, Carolina Wren 2, American Robin 52. European Starling 50, American Tree Sparrow 4, Song Sparrow 2, White-throated Sparrow 1, Dark-eyed Junco 31, Northern Cardinal 14, Purple Finch 1, House Finch 27, American Goldfinch 24, House Sparrow 18. Our 2015 3<sup>rd</sup> Annual Marsha Lay lake Santee Bird Count Total. Thank you to everyone that participated! Deb

While we enjoy watching the birds that flock to our feeders in harsh weather, it is important to remember that there are over 50 bird species that we see here that do not feed at feeders. They require natural habitat and clean water to survive during good and bad weather. Included are: Bald Eagles, Osprey, Herons (2 species), Geese (4 species), Swans (2 species), Ducks (8 -9 species not Mallards), Common loon, Grebes (2 species), Double Crested Cormorant and Anhinga, Vultures (2 species), Hawks (5 species), American Coot, Sand Hill Crane, Shore birds (2 species), Gulls and Terns (5 species), Owls (6 species), Belted Kingfisher, American Kestrel, Flycatchers ( 2 species), Horned Lark, Brown Creeper, American Robin, Cedar Waxwing, Warblers (2-5 species), Swallows (4 species).

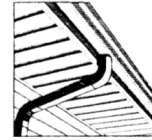

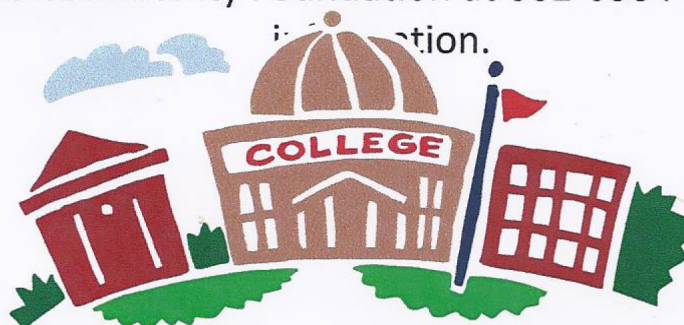

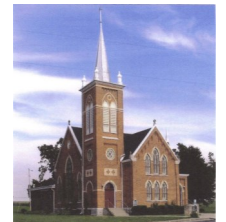

1. Roll Call

Scott called the meeting to order and requested a roll call. Members present were Scott Gibbs, Clair Fredrickson, Jim Hornig, Greg Montgomery, Paul Gosnell, and Ed Fox. Absent was Kathy Tarzwell. Also attending were Brad Jones, Utility Administrator, Brandon Litmer, Utility Superintendent, our attorney Anne Poindexter, and Buzz Krohn of OW Krohn & Associates.

2. Consent Items

- a. Minutes from November 20, 2014
- b. Financial Reports
- c. Register of Claims for sewer operating
- d. Register of Claims for water operating

A motion was made by Ed and seconded by Jim to accept the consent items as presented. The motion carried.

3. Operators Report

- a. Sewer Status Report – Brandon reported that the sewer plant was operating well with no issues. The faulty RAS pump has been repaired and returned. It has been reinstalled and is operating well. The NPDES Discharge Permit Application has been completed and is going through its mandatory notification process. It looks good at this time and the permit should be issued in February.
- b. Water Status Report – Brandon reported that the water plant is operating well with no issues at this time.
- c. Administrator Status Report – Brad reported that there were 119 ACH and 9 Credit Cards during the past month. There were 25 valve turns and 2 shut offs with both still off. Brad received a request from Lot 198 for a sewer adjustment of \$103.26 for filling his pool this past summer. While he is entitled to this adjustment under our current policy for filling pools, the tardiness of his applying for it may be something we will want to look at in the future. A motion to grant the adjustment was made by Clair and seconded by Jim. Motion carried.

4. Committee Reports

- a. Board Member Guide Committee
  - i. Board Training Topic – More on the Management Agreement with the POA to be discussed later in this meeting.

5. Old Business

- a. New Computer / Software for SCADA Update – Brandon talked to both companies that were bidding on this program and found that the major difference in the two bids was the amount of labor costs involved, but the scopes of work included were comparable. He recommended that we go forward with the Toric quote of \$11,900.00 because of the lower price, Toric did the original installation, and Toric has worked well with us over the years when a question or problem came up. A motion was made by Clair that we award the bid to Toric and was seconded by Ed. Motion carried.
- b. Hidden Leak Adjustments – Scott had presented all of the Board members with a draft of proposed additions to our Ordinance No. 07-20-2005 covering this subject. After some discussion, it was determined that a few changes should be made. Scott will make these in time for further review at our next meeting.
- c. Disaster Recovery Plan – Ed contacted Napoleon Water Utility to see if they would be interested in a co-op plan with us. The response was very positive. More talks will be held in the future on making this happen. Brad submitted our application to join the

inWarn program, but has not had an acknowledgement yet to inform us of our being a member at this time.

- d. Management Agreement – Scott asked Dick Veach, president of the POA, to go over the major components of the Agreement and explain the differences for the 2015 agreement. A motion was made by Jim to accept the agreement and seconded by Greg. Motion carried.
  - e. Bond Refunding – The financial advisor, Buzz Krohn of OW Krohn & Associates, LLP attended this meeting to go over our financials and review the 3 refunding proposals we received to see if refinancing our bonds at this time makes sense. Buzz explained in quite a bit of detail that this might not be the best time to do this. He would like to see all the numbers after the first of the year to really get a better picture before we make this decision. We agreed to continue this at the next meeting.
  - f. North Gate – License Agreement with POA – Anne drafted a License Agreement to be approved by the Board to give temporary permission to the POA to use District property to enter and leave the Lake through the North Gate. Several pros and cons related to having an open North Gate versus having a closed North Gate were re-discussed. A motion was made by Ed and seconded by Greg to approve the License Agreement. Motion carried by 3 yea votes and 2 nay votes. Jim Hornig was called away from the meeting on a security call leaving only 5 members.
6. Attorney's Report – Anne reported that she participated (as amicus curiae for the IRSDA) in a law suit for another sewer district before the Indiana Supreme Court pertaining to tax liens being filed to collect past due bills.   - b. Correspondence – Brad received a letter from Rural Development thanking us for submitting our budget for 2015, saying they agree and think it is OK. He also received an e-mail from the State Board of Accounts concerning Form 100-R. He has already submitted it to them.
  - c. Upcoming Conferences / Training Classes – None at this time.
  - d. Salary Differentials – A review of the wage differentials was conducted with most being in line with comparable positions elsewhere. It was proposed that 2 adjustments be made. A motion was made by Greg and seconded by Paul to make the wage differential adjustments as proposed. Motion carried.
