Reminder: All boats on Lake Santee require 3" lot numbers and a current permit on each side of the boat. This includes paddle boats, canoes, rowboats, kayaks, inflatable kayaks, etc.

## **BOATING**

- 4.2 All boats shall have affixed the property Owners' lot numerals, in a contrasting color, not less than three (3) inches in height. Lot numbers shall be placed in the middle of the boat on each side thereof, clearly visible to the Lake Patrol at all times.
- 4.3 All watercraft must have a current permit affixed on the port (left) and starboard (right) side of the boat near the lot number or on the left and right side windows prior to launching. Annually, upon payment of dues, assessments and fees, members shall be entitled to purchase registered boat permits, which authorize them access to Lake Santee. Permits will be available in five different classes depending on the type of boat. The Board of Directors shall determine from time to time the amount of fee to be charged for such permits.
- 4.4 Boat permits shall be purchased on an annual basis and shall be in effect from the first day of March until the last day of February of the following year.





### PROPERTY OWNERS ASSOCIATION TEAM BASS TOURNAMENTS

### **Official Rules**

- 1. All Lake Santee rules and bylaws will be followed.
- 2. There will be a mandatory meeting FIFTEEN (15) minutes prior to the start of the tournament at the Lake Santee Main Beach Shelter. Those teams not entered prior to the meeting will be disqualified unless prior arrangements have been made with tournament official(s).
- 3. Boat positions will be determined at the mandatory meeting by a number draw. The start will be a continual "ooze off" of boats by the position drawn.
- 4. A mandatory boat check will be conducted prior to the start of the tournament.

  All boats must be equipped with an aerated livewell capable of sustaining a limit of bass.
- 5. Safe boating must be observed at all times. <u>Each participant is required to wear a USCG approved life preserver</u> and the kill switch should be working properly any time the combustion engine is in operation prior to and during tournament hours.
- 6. Only largemouth, smallmouth, and spotted (Kentucky) will be counted towards the daily limit of five (5) bass per team. Only artificial baits may be utilized in competition, including pork type trailers.
- 7. Only bass measuring sixteen (16) inches or longer will be weighed. The official board will be the Golden Rule. No short fish will be counted towards daily limit. The penalty for weighing short fish will be the weight of short fish plus two (2) ounces per fish deducted from the total of the legal fish that are weighed in.
- 8. No dead bass will be counted. All bass must be released in healthy condition. Any bass which fails to swim away upon release will be scored as a dead fish and the weight of that fish plus eight (8) ounces will be deducted from that teams' remaining weight.
- 9. Participants will not be allowed to leave the boat during tournament hours. Participants may briefly leave the boat for an exigent emergency or answer the "call of nature".
- 10. All ties will be determined by combining the prizes and dividing it equally between the respective teams. All protests must be made in writing within **TEN** (10) minutes of tournament conclusion.
- 11. No cheating will be tolerated and contestants may only use artificial baits during competition.
- 12. Competitors are expected to follow a high standard of sportsmanship, safety, and conservation. Alcohol and abused drugs will not be consumed during tournament hours.
- 13. The Tournament will be a two (2) man team style format. At least one member of each team must be an L.S.P.O.A. member in good standing. Members may fish alone and be considered a team.

## The Plight of the Monarch

Not the king or the queen of wherever, but the BUTTERFLY, the most beloved of all insects. Declining populations and threat of extinction are gaining world-wide attention as efforts increase to identify and address the causes of its decline. Recent articles in the Greensburg Daily News, The National Wildlife Federation magazine, a program by NOVA and a report on CBS Sunday Morning among many others, point to natural predators, bad weather, habitat loss, agrichemical use and climate change as some of the problems that Monarchs face on their 2,000 mile migration from Mexico to Canada and back over a 1-year cycle. Their success is nothing short of a miracle. It takes 4 generations, egg laying and hatching occurring in Texas, the Midwest and Canada to create the population that returns to Mexico over desert, water and across mountain ranges. "It's one of the most wonderful planetary cycles on Earth." (NOVA)

Here's how you can help: 1) plant native milkweeds and butterfly weed. They are the source of food for caterpillars. 2) cultivate native nectar plants, especially for spring and fall migrations. They include Black-eyed Susan, Blanket Flower, Blazing Star, Blue Beard, Butterfly Bush, Cone flower, Ironweed, Lantana, Mexican Sunflower, and Verbena. 3) avoid pesticides, especially systemic insecticides such as neonicotinoids (nicotine based). 4) participate in citizen science. "Biologists need volunteers to help study monarchs." You can become a citizen scientist through

any of the following websites: Monarch Watch, Journey North, Monarch Health, Glorious-Butterfly and Butterfly Encounters, to name a few. (National Wildlife Federation.) As Charles Osgood said on CBS Sunday Morning, "If we can't save the most adored of all our butterflies,

what can we save?'

At my feed I still have been seeing Towhee, Cardinals, Chickadee, Dove, Goldfinch, House Finch, Purple Finch, Blue Jay, Junco, White-breasted Nuthatch, Song Sparrow, American Tree Sparrow, Titmouse, Downy, Hairy, Pileated and Red-bellied Woodpeckers and off and on my Carolina Wren. I do believe I have the fattest birds in the county as much feed as I they eat.



#### 1. Roll Call

Scott called the meeting to order and requested a roll call. Members present were Scott Gibbs, Clair Fredrickson, Kathy Tarzwell, Jim Hornig and Paul Gosnell. Absent were Ed Fox and Greg Montgomery. Also attending were Brandon Litmer, Utility Superintendent, and the District's attorneys Anne Poindexter and Scott Wyatt.

#### 2. Consent Items

- a. Minutes from January 15, 2015
- b. Financial Reports
- c. Register of Claims for sewer operating
- d. Register of Claims for water operating

A motion was made by Kathy and seconded by Jim to accept the consent items. Motion carried

#### 3. Operators Report

- a. Sewer Status Report: Brandon reported that the Sewer Plant was operating on a normal basis with no problems and all tests were good. He also told us that he had received the N.P.D.S. Permit which is good for 5 years.
- b. Water Status Report: Brandon reported that the Water Plant was operating on a normal basis and all tests were good.
- c. Administrator Status Report: In Brad's absence, Brandon reported that we had 6 valves turned last month. There were 121 ACHs and 12 Credit Card payments. We had 5 disconnects with 1 still off at the time of this meeting. Brandon submitted the annual maintenance agreement for our Jay Hawk Software computer support in the amount of \$700.00. A motion was made by Clair and seconded by Jim to approve the agreement. Motion carried.

### 4. Committee Reports

- a. Board Member Guide Committee
  - i. Board Training Topic: No training program this month.

#### 5. Old Business

- a. Hidden Leak Adjustments: Our new ordinance covering this subject was discussed at length. It was felt that the wording of this new version is what we want. Anne will put it in its final form for approval at the March meeting.
- b. Napoleon Water Update: Nothing to report at this time.
- c. Bond Refunding: Scott and Anne presented a report that was up to date with the year-end financial numbers and projections of our proposed refinancing of the outstanding Water and Sewer Bonds. A letter was read from Buzz Krohn with his recommendation of proceeding with the Piper Jaffray proposal. Based on this and all of the other information that has been reviewed with us, Anne brought with her an Ordinance that we labeled Ordinance 2-19-2015 to acknowledge to the Bond purchaser that the District was ready to proceed with the refunding. Clair made a motion that we proceed with the refinancing of all of the outstanding bonds for both the Sewer and Water bonds. It was seconded by Kathy. Motion carried. Based upon this motion, Anne will have all four parties proceed with formalizing the refunding of the bonds and create the new Bond Ordinance. A special meeting was then scheduled for March 4, 2015 to formally pass the Bond Ordinance and execute all of the necessary documents.

### 6. Attorney's Report

Anne told us about H.B. 1496 that, if made into law, would dramatically change our ability to collect past due bills and alter the way our board is selected. She encouraged us to contact our legislators and let them know how we felt about this bill.

### 7. New Business

- a. Write-Offs: There were four (4) accounts presented for write offs this month. Lot #759 for \$92.74 and Lot #949 for \$63.76, both from tax sales. Lot #1659 for \$189.58 for amounts incurred after the sale of a property. Kathy made a motion to write off these 3 amounts, Jim seconded, and motion carried. The fourth item was Lot #735 for \$63.76 more information is needed after Brad returns before this account can be decided upon.
- b. Leak Adjustments: Lot #456 in the amount of \$418.81 and Lot # 90 in the amount of \$266.17, both for frozen water pipes in Dec. and Jan. It was determined in the following discussion that both homeowners made repairs as soon as possible. Jim made a motion to adjust both amounts and Kathy seconded it. Motion carried.
- c. Correspondence: None at this time.
- d. Upcoming Conferences / Training Classes: None at this time.
- e. AWWA Conference Report: Brandon attended this conference and felt it was a good meeting, especially on the Sewer portion. Brandon earns many of his needed CEU credits to maintain his license at this conference.
- f. ETC Building on RWWD Property: ETC requested permission to construct a building next to the water tower. The building will be approximately 15' x 20' in size. It will have a brick exterior and will be landscaped. The purpose of the building is to house ETC's equipment for the proposed fiber optic wiring to the lake. After hearing their proposal and a lengthy question and answer session, ETC was told they could proceed with the planning stage of this program. ETC is to submit to the District more detailed information regarding their responsibilities and financial proposal before any final decisions are made this information will need to be reviewed with Anne, as well.
