RESOLUTION 8-19-2009



 the following described Real Estate in Decatur County, Indiana, to-wit:

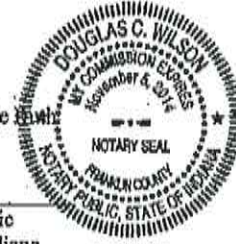
