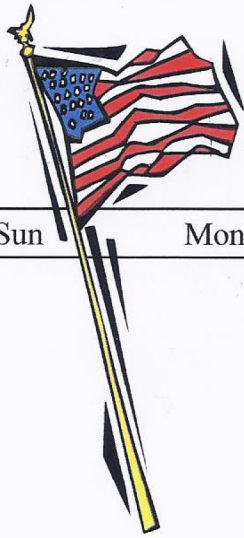

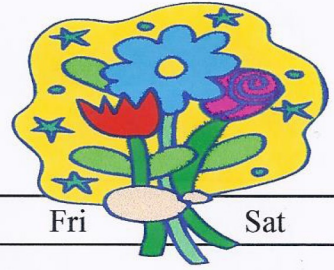

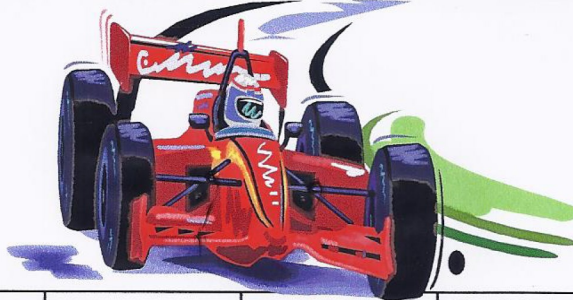

Water Tubing Tips: Boat Safety Tips for Water Sports Tubing

The next time you or your family decide to go out boat tubing, keep these boating safety and water sports tubing tips in mind to make sure your experience is safe and enjoyable:

1. **Always wear a PFD**

While it's always a good idea to wear a PFD (personal flotation device) when onboard, it should go without saying that you should wear a life jacket when water tubing. This is especially important in the event that the rider should become separated from the boat.

2. **Know your equipment**

Be familiar with the capabilities of your water sports tubing equipment. It's important to follow to the manufacturer's recommendations for water tubing capacity in terms of size and weight, number of riders, age limits, and maximum towing speed.

3. **Know your rider**

It's also important to use common sense when it comes to the capability of your rider, especially when water sports tubing with small children. While sharp turns, high speeds, and big waves can be fun, these should never come at the expense of rider safety.

4. **Use a spotter**

Designate one person onboard as a "spotter", who can not only keep a lookout for water tubing accidents or to see if anyone has fallen off the tube, but can also help keep the boat driver informed at all times.

5. **Be aware of water regulations**

Make sure you are familiar with the specific regulations governing the body of water you're boat tubing on, in particular towing speeds.

6. **Drive Responsibly**

The driver should be alert, sober, and have a solid grasp of boating rules and regulations. Be respectful of and keep your distance from other boats in the area when water tubing, and always keep an eye out for additional water hazards such as rocks, docks, and buoys.

7. **Use a secure tow line**

Another important safety aspect of water tubing, it's important to always make sure that the tow line is securely tied before take off. Also be sure to check for signs of wear, tear, and fraying, and replace as needed. Be sure to only use rope that is specifically designated for towing inflatables.

8. **Check before you start**

Never start the boat without first making sure that your rider is ready to go. This means that they have a firm grip on the line, are properly positioned on the tube, and that the line is properly and safely positioned. When water tubing with multiple passengers, riders should understand how to balance their weight correctly and work together to safely stay on the tube.

9. **Handle wakes with care**

Slow the boat speed when crossing wakes. Bouncing off wakes at extremely high speeds has been known to cause back injury, especially with riders who are water tubing stomach-down.

Exercise caution when pulling more than one tube

It's especially important to travel at slower speeds and keep an extra careful eye out if you are boat tubing with more than one tube. Dual water sports tubing can often result in large crashes and serious accidents, should the tubes happen to collide.

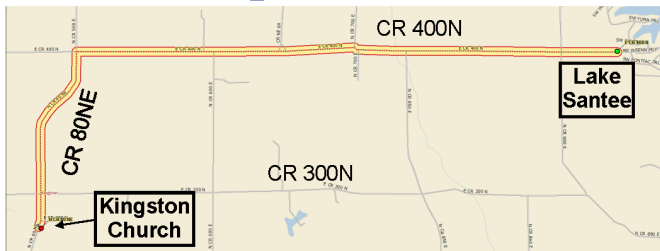

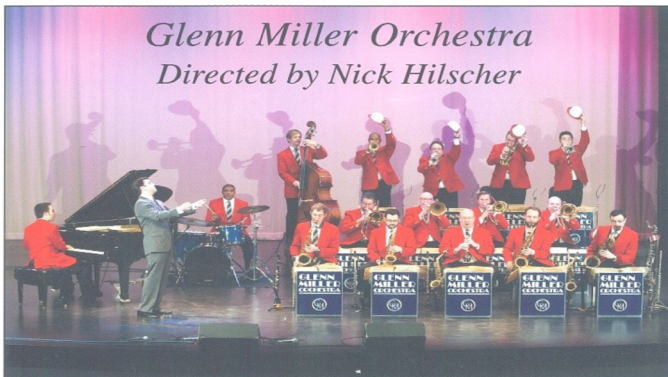

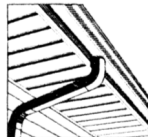

PROPERTY OWNERS ASSOCIATION TEAM BASS TOURNAMENTS

Official Rules

1. All Lake Santee rules and bylaws will be followed.
2. There will be a mandatory meeting FIFTEEN (15) minutes prior to the start of the tournament at the Lake Santee Main Beach Shelter. Those teams not entered prior to the meeting will be disqualified unless prior arrangements have been made with tournament official(s).
3. Boat positions will be determined at the mandatory meeting by a number draw.
The start will be a continual "ooze off" of boats by the position drawn.
4. A mandatory boat check will be conducted prior to the start of the tournament.
All boats must be equipped with an aerated livewell capable of sustaining a limit of bass.
5. Safe boating must be observed at all times. Each participant is required to wear a USCG approved life preserver and the kill switch should be working properly any time the combustion engine is in operation prior to and during tournament hours.
6. Only largemouth, smallmouth, and spotted (Kentucky) will be counted towards the daily limit of five (5) bass per team. Only artificial baits may be utilized in competition, including pork type trailers.
7. Only bass measuring sixteen (16) inches or longer will be weighed. The official board will be the Golden Rule. No short fish will be counted towards daily limit. The penalty for weighing short fish will be the weight of short fish plus two (2) ounces per fish deducted from the total of the legal fish that are weighed in.
8. No dead bass will be counted. *All bass must be released in healthy condition. Any bass which fails to swim away upon release will be scored as a dead fish and the weight of that fish plus eight (8) ounces will be deducted from that teams' remaining weight.*
9. Participants will not be allowed to leave the boat during tournament hours. Participants may briefly leave the boat for an exigent emergency or answer the "call of nature".
10. All ties will be determined by combining the prizes and dividing it equally between the respective teams. All protests must be made in writing within **TEN (10)** minutes of tournament conclusion.
11. No cheating will be tolerated and contestants may only use artificial baits during competition.
12. Competitors are expected to follow a high standard of sportsmanship, safety, and conservation. Alcohol and abused drugs will not be consumed during tournament hours.
13. The Tournament will be a two (2) man team style format. At least one member of each team must be an L.S.P.O.A. member in good standing. Members may fish alone and be considered a team.

Perfect Day, Perfect Wildflowers

It couldn't have been a more beautiful day at The Nature Habitat. Eight of us enjoyed perfect weather while finding the blossoms of bloodroot, buttercups, crinklewort, toothwort, trout lily, Dutchman's breeches, hepatica, rue-anemone, spring beauty, yellow and blue violets, and wild ginger. We missed the blossom of the skunk cabbage but there was the promise of May apple, sweet William, trillium, Virginia waterleaf and wild leek in plentiful foliage. Yet to come are Jack-in-the-Pulpit, wild geranium, golden seal, Solomon's seal and white bane berry, among others. Thank you, Betty Gabbard, for being our guide. There are ID brochures in the box at the head of the trail so when you need to take a break, take it at The Nature Habitat and discover Nature's world. You'll be glad you did.



They're Back!

We know spring is officially here when ospreys and purple martins are back from their winter habitats, fishing and eating bugs at our lake. Providing nesting boxes and platforms is a good way to encourage these birds to take up residence here. Ospreys have been spotted on one of the perches so there is hope for a nesting pair this year! There have been hummingbird sightings too. Welcome them with nectar (1C sugar to 4C water) in a feeder and then enjoy the show. Female wood ducks are laying eggs and taking up residence in their boxes while the very handsome male patrols out front. Cardinals and American goldfinches are in full color. Never a dull moment in breeding season at Lake Santee!

The meeting was adjourned and members went to Aspen Place in Greensburg for a delicious lunch and an enjoyable tour of the facility.

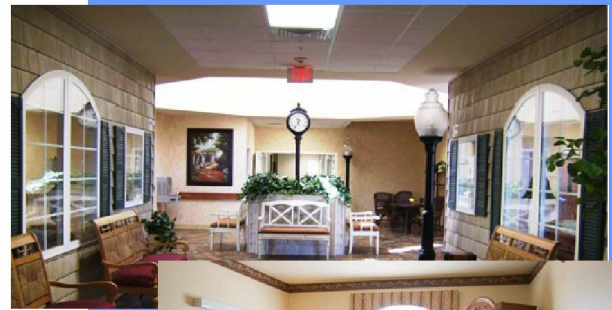

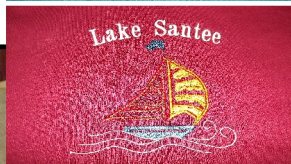

The lake level is up and no wake buoys are set out.

Ron stated that the maintenance crew has begun grading the gravel roads and will be adding gravel.

Security – John Lecher

John reminded property owners that all watercraft must have lot numbers and lake stickers on before it is placed in the water. He stated that watercraft includes, kayaks, canoes, inflatable kayaks, paddle boats, and paddle boards.

Angel asked for clarification related to a security call of four wheelers being used a members own property because this use is within the rules. The complaint was on an owner during day hours and the vehicle was on the owner's property.

Larry asked for clarification on stickers needed to be placed on blow up kayaks. All types of boat must have a sticker and lot number. This does not included personal floatation devices. The board and security had a lot of discussion about this and Dick stated the board should revisit this issue. John recommended that water craft should

include blow-ups boats. I would be impossible to cover all types of boats therefore per the rule this is covered as the "etc" . Dick stated the Lake would make that decision public.

OLD BUSINESS

ETC Update

ETC will be coming back to discuss the location of the boxes for fiber optic cable connections that will need to be placed around the community and are still working with the water district on placing the main hut on the water tower lot. ETC will be meeting with the lake soon to narrow down the connection locations. All zone connection boxes will be set on Lake owned property and not on individual member properties. The project will be completed in quadrants and time frame is not definite.

North – License agreement

License agreement with the Water District had been renewed for a year. The gate is now open 24 hours a day. The agreement is good through April of 2016. If the lake chooses to make any permanent improvement to the property, the Water Board would like the lake to seek permissions from them first. Until the permanent location is determined the lake will continue to review and monitor.

MANAGER'S REPORT

Collect \$2,856.25 in bad debt this month.

Brad discussed that at the last month's board meeting there had been some discussion and a statement that the lake had some issues with criminal activity last month. Brad felt compelled to investigate. He went to the Decatur County Sheriff's Department and

checked their records. There had been three reports of criminal activity at the lake; two were domestic violence issues and the third was an identity theft where the property owner went to file their taxes and realized they had already had them filed for them. Other incidents included car accidents and EMS calls. No criminal activity has been reported this month. Brad also clarified the report of the meth lab removal. An officer drove down road 880 along the outside of the lake and saw that a meth lab had been disposed along side the road. Lake security aided in the removal of this. Brad wanted to reassure residence that there has been no increase in crime or criminal activity within the lake community.

Lake office is open on Saturdays now.

The lake website is up and running and Brad is placing new photos from lake activities on the site. He is always open to feedback on the site.

Dick revisited the mailbox issue. There will be a letter going out in the smoke signal about abandoned mailboxes and their removal. Dick also stated that the lake is looking into getting a secure mailbox where members can mail items if they are not comfortable in mailing for their personal mail boxes. Ron accepted the assignment into looking into this and a location for the secure box.

Heavy trash dates will be set soon.

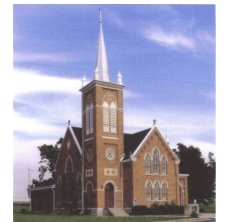

1. Roll Call

Scott called the meeting to order and requested a roll call. Members present were Scott Gibbs, Clair Fredrickson, Kathy Tarzwell, Greg Montgomery, Jim Hornig and Paul Gosnell. Absent was Ed Fox. Also attending was the District's attorney Anne Poindexter, Utility Superintendent Brandon Litmer, and Utility Administrator Brad Jones.

2. Consent Items

- a. Minutes from February 19, 2015
- b. Minutes from March 4, 2015 (Special Meeting)
- c. Financial Reports
- d. Register of Claims for sewer operating
- e. Register of Claims for water operating

A motion was made by Kathy and seconded by Clair to accept the consent items as presented. Motion Carried.

3. Operator's Report

- a. Sewer Status Report: The sewer plant is operating well with no issues due to the cold weather. Brandon reported that the last pump and tank from inventory had been installed. An order has been placed for 4 more sets and 3 extra pumps to keep in inventory.
- b. Water Status Report: The water plant is operating well with no issues. The new computer and SCADA system has been installed and is up and running with no issues. Brandon reported the water mains would be flushed on Thursdays during the month of April.
- c. Administrator Status Report: Brad reported there were 9 valve turns, 3 shut offs with all back on, 121 ACHs, and 7 credit card payments this month. Brad suggested that the District consider setting up a web site. He explained that the office gets numerous calls with questions about the District and the information that is posted on the web site could answer many of these inquiries. A motion was made by Clair and seconded by Kathy to have Brad set up the web site. Motion Carried.

4. Committee Reports

- a. Board Member Guide Committee
 - i. Board Training Topic: Property Owned by Lake Santee RWWD. Scott presented a listing and a marked-up map of the property owned by the District.

5. Old Business

- a. Hidden Leak Adjustments: It was felt that all of the issues have been covered. Anne will put the ordinance together in the proper language and present it at the April meeting.
- b. Napoleon Water Update: No activity this month.
- c. Bond Refunding: The old bonds have been paid off and the new bonds issued. The cost of issuance fees still have to be paid. Anne and Jarod (from Krohn) will review the completed transactions at the April meeting.
- d. ETC Building on RWWD Property: ETC's proposal to build a 15'x20' permanent building next to the water tower was reviewed and discussed. ETC had offered a one-time easement payment of \$1500 plus reasonable costs of the transaction. The Board felt \$1500 for a permanent building was insufficient and did not act to accept the proposal. A motion was made by Kathy and seconded by Jim to have Anne contact ETC to discuss more appropriate terms related to a permanent structure.

6. Attorney's Report: Anne reaffirmed that the refunding of the bonds was complete.

7. New Business

- a. Write-Offs: Brad presented 3 properties for write off. Lot #735 for \$63.76 and lot #1465 for \$63.76 which were outstanding amounts carried over from a tax sale. Lot #1636 for \$137.71 – this amount was incurred just before the property was foreclosed. A motion was made by Jim and seconded by Clair to write off these 3 amounts. Motion carried.
- b. Correspondence: Brad reported the office received a letter from the Indiana Regional Sewer District Association covering many subjects, including the invoice for annual dues.
- c. Upcoming Conferences / Training Classes: No training classes are scheduled at this time. Jesse continues to study for the May water test with Brandon's guidance. Once Jesse passes the operator's exam, he will become the backup operator for the water plant in the event anything happens to Brandon.
- d. Letter from POA on North Gate: The POA has requested an extension of the current license agreement related to the North Gate property (Tract 5/Lot 1686). The request was discussed at length and it was agreed to extend the agreement for an additional year, beginning 4/1/15, with some additional language. Greg made a motion to this effect and was seconded by Kathy. Motion carried.

You have the option of having your water bill payments made by automatic withdrawal from your checking or savings account. This can be for the water user accounts as well as the availability accounts. The forms may be obtained from the office or downloaded from our website. You must be logged in on the website, go to Utilities, click on the water tab and it is the last form on the list.

Homeowners Pumps

Your grinder pump is not a garbage disposal. The following items should not be put in your system: Glass metal, diapers, socks, rags, cloth, plastics, sanitary napkins, tampons, explosives, flammable materials, lubricating oils or grease, strong chemicals, gasoline, sand, gravel, fish scales, cleaning fluids, pesticides, herbicides and toxic chemicals. The District owns the grinder station and customers are not permitted to open the tank or control panel.



If the red light on the electric box for your grinder pump is on, it means your pump is not working properly. During regular business hours call the office at 527-2943. After regular hours call 560-1157 if you see your light or your neighbors' light on.

A district employee will respond promptly. Also remember, there is an ordinance that prohibits the planting of trees, flowers, shrubs or other plantings within five feet of the station to allow accessibility. In addition no plantings shall be placed on the side of the pump facing the nearest road to promote visibility of the visual alarm from the roadway. Painting of the control panel or pump tank is prohibited.
