

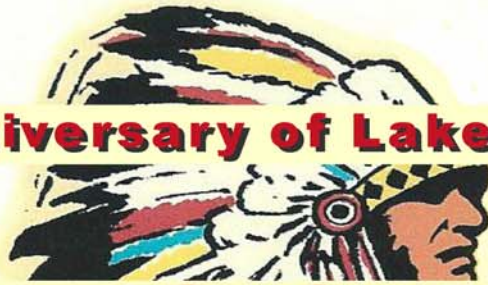

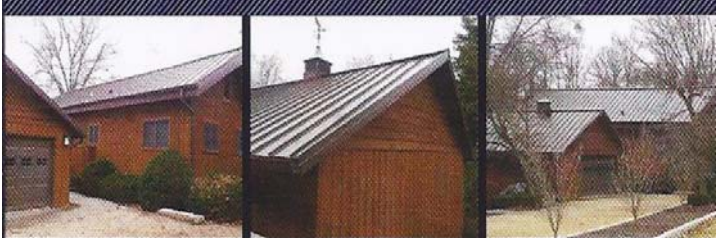

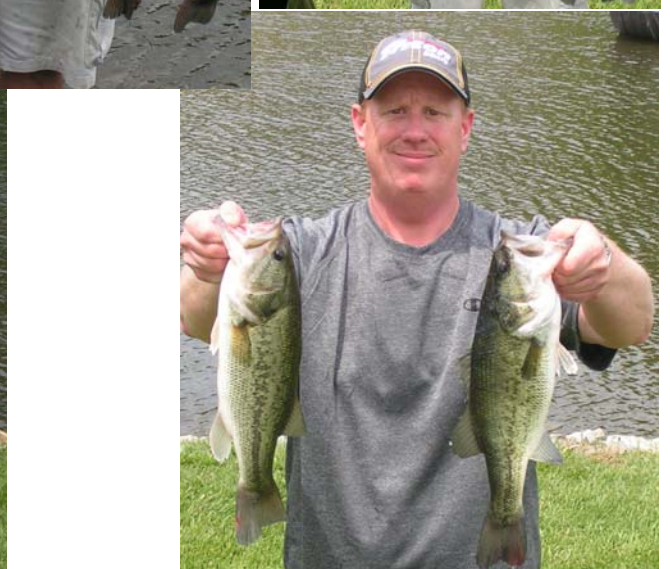

## LAKE SANTEE

### PROPERTY OWNERS ASSOCIATION TEAM BASS TOURNAMENTS

#### Official Rules

1. All Lake Santee rules and bylaws will be followed.
2. There will be a mandatory meeting FIFTEEN (15) minutes prior to the start of the tournament at the Lake Santee Main Beach Shelter. Those teams not entered prior to the meeting will be disqualified unless prior arrangements have been made with tournament official(s).
3. Boat positions will be determined at the mandatory meeting by a number draw.  
The start will be a continual "ooze off" of boats by the position drawn.
4. A mandatory boat check will be conducted prior to the start of the tournament.  
*All boats must be equipped with an aerated livewell capable of sustaining a limit of bass.*
5. Safe boating must be observed at all times. Each participant is required to wear a USCG approved life preserver and the kill switch should be working properly any time the combustion engine is in operation prior to and during tournament hours.
6. Only largemouth, smallmouth, and spotted (Kentucky) will be counted towards the daily limit of five (5) bass per team. Only artificial baits may be utilized in competition, including pork type trailers.
7. Only bass measuring sixteen (16) inches or longer will be weighed. The official board will be the Golden Rule. No short fish will be counted towards daily limit. The penalty for weighing short fish will be the weight of short fish plus two (2) ounces per fish deducted from the total of the legal fish that are weighed in.
8. No dead bass will be counted. *All bass must be released in healthy condition. Any bass which fails to swim away upon release will be scored as a dead fish and the weight of that fish plus eight (8) ounces will be deducted from that teams' remaining weight.*
9. Participants will not be allowed to leave the boat during tournament hours. Participants may briefly leave the boat for an exigent emergency or answer the "call of nature".
10. All ties will be determined by combining the prizes and dividing it equally between the respective teams. All protests must be made in writing within **TEN (10)** minutes of tournament conclusion.
11. No cheating will be tolerated and contestants may only use artificial baits during competition.
12. Competitors are expected to follow a high standard of sportsmanship, safety, and conservation. Alcohol and abused drugs will not be consumed during tournament hours.
13. The Tournament will be a two (2) man team style format. At least one member of each team must be an L.S.P.O.A. member in good standing. Members may fish alone and be considered a team.

You may get to see a baby skunk or possum or raccoon; or an owl or hawk; or a tortoise or a turtle. All of them are rescued and have their own story from reptiles to raptors. This is your chance to experience nature at its closest!

The trails through The Habitat are groomed and ready for hikers. Boy Scouts will be available as guides and assistants on the trails. Snacks and beverages will be served to welcome you. Be sure to stop by The Nature Habitat to visit the place that original Lake Santee residents, Abba Hutton-Stitts and Charlie Stitts, saw as a human and wildlife refuge.

## **Utopia Wildlife Rehabilitators to the Rescue**

Chick and Kathy Winzenread found a disabled turtle in their yard, called it Myrtle the Turtle and took her to Kathy Hershey at Wildlife Rehabilitators. Come to find out it's a male, and since he was found on land, has been renamed Morris the Tortoise. According to Wikipedia Eastern Box Turtles are "terrestrial members of the American pond turtle, and not members of the tortoise family." So, to be correct, he is now Morris the Turtle. Morris was taken to the vet for evaluation and found to have a cracked lower shell and paralysis in his front legs. The prognosis is not very good for Morris but he is receiving the best of care. "While not yet recognized as an endangered species by the U.S government, it (box turtle) has very little protection from developers and pet owners."

([www.wildlifewatchers.org/report\\_30](http://www.wildlifewatchers.org/report_30)). Threats to their survival include "habitat loss and fragmentation, road mortality and removal from the wild."

([www.naturalheritage.com/citizenscience](http://www.naturalheritage.com/citizenscience)). Some states have issued protections for box turtles but many still allow them to be collected for pets, a very bad idea for the turtle. It used to be a common experience to come across a turtle crossing the road. In my family a “turtle alert” was called, which resulted in a traffic check, flashers engaged, pull-off to the side and a sprint back to help the turtle off the road in the direction in which he was headed. If Morris makes it and is releasable, he will be returned to the backyard woods where he came from. Thank you, Chick and Kathy, for taking care of him.

## Hummingbird Nectar Recipe

Use 1 part sugar to 4 parts water. Boil 1-2 minutes and cool and store in refrigerator. DO NOT use honey or artificial sweeteners. DO NOT use red food coloring or buy red colored nectar as it could harmful to your birds and is not necessary to attract them. Red color on the feeder is enough to attract them. Happy Humming!

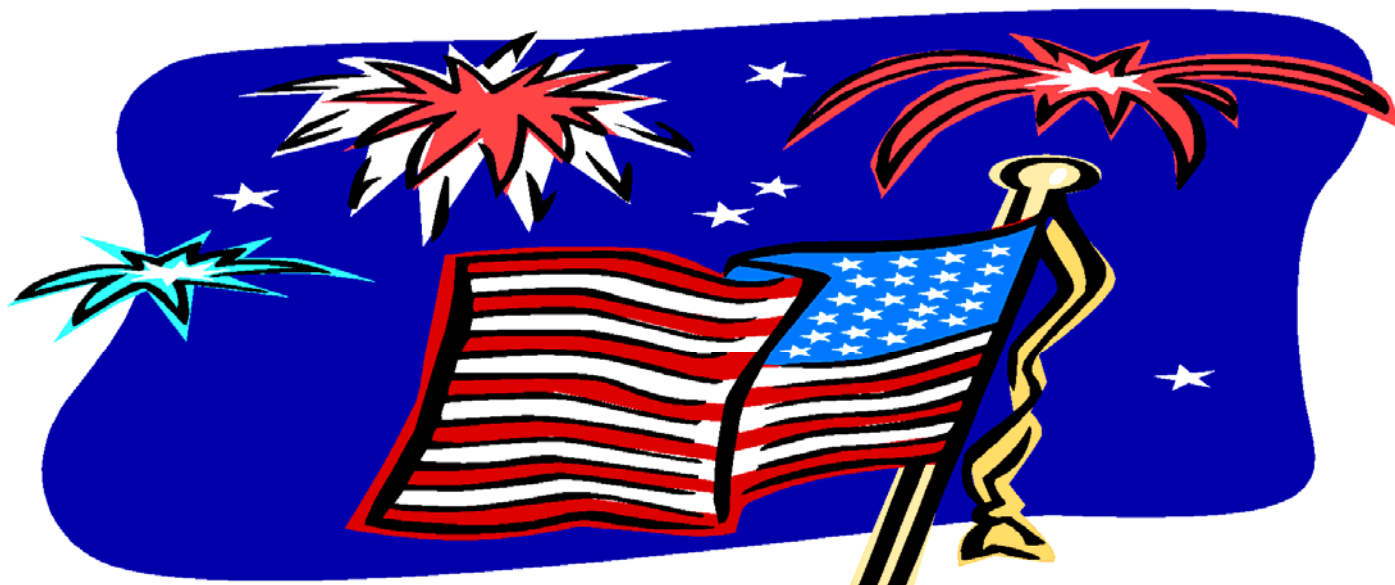

President Veach called for a review of the minutes of the April 8, 2015 meeting. The minutes were approved on a motion by Carol Goodwin, seconded by Mike Cutrufelli.

In Angel's absence, Dick Veach gave a brief review of the Treasurer's report. The Treasurer's report was approved subject to audit.

After presentation, the bills were approved for payment on a motion by Mike Cutrufelli, seconded by Carol Goodwin. Dick mentioned that the Women's Club paid for the soffit used on the community room overhang and thanked them for graciously donating the money for that.

## **MEMBERS INTRODUCTION AND COMMENTS**

Members were asked to introduce themselves and given the opportunity to express comments.

## **CORRESPONDENCE**

The lake received a letter from the Decatur County Family YMCA thanking the Lake for the successful triathlon held last year. They are looking forward to holding the 4<sup>th</sup> annual triathlon event at the Lake this year on September 12<sup>th</sup> and would like to add a duathlon that will consist of 2 mile run, 13 mile bike ride, and 5k run. The routes will be the same as the triathlon so no additional roads will be affected. Dick asked for a motion to approve this request. Carol Goodwin presented a motion, Mike Cutrufelli seconded. The motion passed.

The Lake received an email from Chip Ayers of the bass club asking to be able to bring some students from North Decatur Jr/Sr High School to go fishing. He has been working as a mentor for this group of at risk boys. They have obtained a donation for rods and tackle for the boys previously but have not been successful as of yet. He is asking for permission for himself, and a couple of other adults to bring the boys out to go fishing. Mr. Ayers is a member of the Lake but would like to request approval. A motion was made and the board approved by Mike Cutrufelli, and John Lecher seconded.

The lake received another thank you letter from Ray Hoffbauer (546) for the opening and use of the North gate.

The Lake received another letter from Jay Stegman asking to purchase lots 731, 732 from the association. The couple would like to offer \$4,000 for the two lots combined, putting a \$1,000 deposit and \$200 a month in payments until paid in full. Brad stated that the offer is an acceptable offer for the lots. Carol Goodwin made a motion to accept the offer contingent to property not being transferred until the price is paid in full. Larry Foster seconded. John Lecher asked if this would be considered as a land contract and if we have done this before. The Board had some discussion and decided that the offer is reasonable but there needs to be some type of written agreement for their protection and ours. Dick stated that the Board should get advice of council before continuing with the motion. Carol amended contingent to our getting the attorneys guidance and including lawyer fees in with the price of the lots and written documentation. Larry seconded the motion with amendments. Motion was defeated 4 to 3, which included a tie breaker vote by Dick.

## **COMMITTEE REPORTS**

### **Rules & Regulations – Polly Ann Fox**

Nothing at this time.

### **Recreation – Mike Cutrufelli**

Mike reported that Carol has a letter that will go to the Chamber advertising the 50<sup>th</sup> Jubilee.

A bench is being constructed by the maintenance crew, which will house the time capsule. The time capsule is in the process of being filled. The bench will have a plaque with the Indian head and the Lake logo, “One of Indiana’s Finest Lake Developments” and 2015 to be opened 2040.”

Mike thanked Paul, Nancy, Shannon, and Scott for all of their work on the Lake’s Commemorative History Book. Books are on pre-order sale now and will be on sale at the celebration. Pre-orders should go to Paul or Nancy and the cost of the book is \$5. Mike said that numerous groups are getting involved in planning and participating in the celebration. There will be four bands, coffee and donuts starting at 9:00 am, as well as numerous other events throughout the day. Mike stated that a timeline of the activities will be in the next edition of Smoke Signals.

Mike also explained that the committee is looking into sending out a flyer/invitation to all members. Ronda is still accepting and seeking sponsorships for the event. Sponsors can pay \$250 to get their names on the back of the shirts being made.

Mike announced other upcoming events and dates:

May 17 – bass tournament

May 20 – the next planning meeting for the 50<sup>th</sup> jubilee at 7:00pm in the community room.

May 23 – Clarksburg Community Volunteer Fire Dept. pancake breakfast fund raiser at the new fire house.

July 4 – Independence Day celebration with a water slide and “Frozen” 5 in 1 bounce house/slide for kid’s activity along with the Beach Bash, a band, and ending with the fireworks.

July 5 – Youth fishing tournament.

Nancy mentioned that people competing in the fishing tournaments do not have enough parking space for their boats and asked for some additions to the dock area. Each additional dock cost around \$2500. Dick mentioned that the Lake would be able to open the gate to the beach which would allow participants to park their boats on the beach.

### **Lakes & Beaches – Larry Foster**

Larry discussed that the budget for the purchase of fish was a total of \$7500. The bid from Clear Creek Fishery came in at \$7700 and this includes 2000 large moth bass (4-6”), 1000 hybrid stripers (5-7”), and 1000 channel cats (6-8”). Larry asked that the board

grant the overage of \$200 to go ahead with the purchase of the fish. Purchase of the fish carried on a motion by Larry Foster and a second by Ron Day. Delivery should be soon, the provider has the fish in stock.

Larry also presented the board with a suggestion to get rid of large carp (trash fish) in the Lake. He requested that he be allowed to set up trot lines at the far end of the fishing area to get rid of some of these fish as well as a small supply budget. This would be a special exception to rule 7.9 concerning setting of trot lines in the Lake. Larry made a motion to allow this exception, allow Larry to set up such lines and allow him up to \$100 to purchase supplies. The motion was seconded and passed five in favor and two opposed.

Larry reported that the Youth Fishing Tournament will be held on July 5. Hilliard Lyons is the main sponsor for the event and will be providing trophies. Other sponsors include the Lake Santee Marina for bait, Roy McQueen, Ken Meyer, TOPS, Rural King, Papa Johns and Little Caesars. Hot dogs, chips, and pop will be provided by the recreation committee.

### **Clean Up – Jim Massingale**

Jim stated that with the upcoming 50<sup>th</sup> Celebration, 33 letters were sent out to property owners asking them to take care of some issues so that the community looks its best for the upcoming event. The office has already received four responses from property owners.

### **Roads & Maintenance – Ron Day**

Ron explained that the amphitheater is about 96% complete, just waiting on fans and electric hook up by Decatur County REMC.

Maintenance crews are getting gravel down on the gravel roads, mowing has begun, and all summer help is on board.

Dick suggested that because the amphitheater is not a shelter, the Board needs to write some verbiage and regulations concerning the use of the amphitheater. Dick volunteered Polly since she is the head of Rules; Carol and John volunteered to assist.

### **Security – John Lecher**

Permanent speed limits signs have been placed around the Santee Drive as well as a stop sign off of the North gate entrance on Tass Trail at Santee Drive.

### **OLD BUSINESS**

#### *ETC Update*

Some of the Lake property owners received a letter explaining the start of construction by ETC. The Board has yet to approve any aspects of the project. ETC has presented a new proposal to the Board replacing the building (hub) with a couple of cabinets and an easement granting for lot 279, an access lot. ETC would use the cabinets and then nodes throughout the property. All lines would be ran on electric poles within Decatur County when possible, but underground in Franklin County. The price of pole usage in Franklin is far too pricey. Carol made a motion that the board approve the signing of easement documents with prior approval of connection box placement as well as all aspects of the project. Mike seconded, motion carried.

#### *North Gate update*

The North gate is still open and is experiencing continued success and approval. The open gate seems to have been beneficial to many people as well as construction crews. Maintenance and Haskamp Excavating has done some work on Taas Trail to fix some soft spots in the road. Decatur County Highway Dept. asked us to widen the radius of the

entrance. The gate has since been removed, and the road widened. This allows for a car to enter and exit the Lake safely.

### *Tree house, Committee report*

The committee that researched the concept of tree houses within the community presented a report and its findings/position. The committee found that at present time the county has no regulations on tree houses except that a railing must be placed on anything 42" high or higher but no permit is required. The #1 complaint about tree houses is the blockage of view and or privacy. The county is currently working on regulations and suggested the lake discourage the use of tree houses due to liability issues. Carol made a motion to not allow tree houses within the community and to amend the rules to state this. The motion was seconded by Jim and carried with a 5 to 2 vote.

## **NEW BUSINESS**

### *Mail Box*

The board discussed the approval of a 12x12x23 locked and secure mail drop box for members to use to mail important bills and letters. After much discussion the board decided to table the decision until we had more information.

### *Paving*

MAC Asphalt offers asphalt rejuvenation. There is a small trial section at the main beach entrance. The product soaks into the asphalt about 2 ½ inches and seals and rejuvenates the actual asphalt surface by filling those cracks. This process lasts about 5-6 years and is considerably cheaper than paving. The Lake could do almost the entire Santee Drive for the price of paving our typical mile. This savings would allow the Lake to use money to address some of the secondary roads with chip and seal or other options. After some discussion, Ron moved that the Board try this new method on 3 miles of Santee Drive. This length of road would allow us to fix some of our damaged areas of road and would take us 2 miles further than conventional asphalt for less money. Mike seconded and the motion carried.

Ron also discussed a new product in place of chip and seal for secondary roads called millings. Ron suggested that the board look into this option by using it on the trash / recycle center. King Asphalt can do this at the Recycle center for \$5,600 to use as a trial surface, this would not include the upper road by the brush dump area. Ron moved that we contract with King Asphalt in the trash / recycle center, seconded by Mike; motion carried.



## MANAGER'S REPORT

The website is up and running and getting lots of visits and hits. Heavy trash is currently going on at the recycle center. Brad stated he was able to save the Lake some money on property taxes for properties that were miss-assessed.

Vicki Schrader suggested the board make a ruling concerning construction being parked on Santee drive before 8 am and after 3 pm due to school bus issues. This has become hazardous and inconvenient. John and Carol are going to look into this matter further.

There being no further business, Mike Cutrufelli moved to adjourn, seconded by Carol Goodwin, motion carried. The next regular meeting will be held on June 10, 2015 at 7:30 PM in the Community Room.

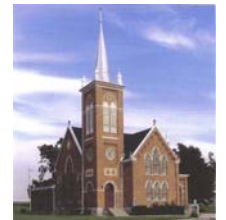

3. Operator's Report

- a. Sewer Status Report: Brandon reported that the sewer plant is operating well with no issues. He has ordered a new meter and probe for use in testing, replacing the original.
- b. Water Status Report: The water plant is operating well with no issues. The HAA5 4-quarter average is nearing its limit, indicating it is time to replace the carbon. Brandon requested approval to purchase the new/reactivated carbon at a price of \$13,000. Kathy made a motion to approve and Greg seconded. Motion carried. Maintenance will have the carbon changed out before the next meeting. Brandon suggested that the water lines be flushed in October (instead of April) going forward. It was decided that maintenance would flush the dead ends now, then the whole system in October.
- c. Administrator Status Report: Brad reported there were 16 valve turns, 1 shut-off with it back on, 121 ACHs, and 14 credit card payments this month. He is continuing to up-date the RWWD web site.

4. Committee Reports

- a. Board Member Guide Committee
  - i. Board Training Topic: Jarrod Hall, CPA with O.W. Krohn & Associates presented a post mortem of the bond refunding that was just completed. He recapped the 3 proposals that were received and evaluated, illustrated the new payment schedules for both the water and sewer bonds, and outlined the savings that will be realized. He stated the District's timing was very good as bond prices have started back up again. The bonds were able to be refinanced at a lower interest rate, cutting 5 years off the term, now ending in 2040. He reminded the District that much of the savings occurs at the end of the shortened payment period.

5. Old Business

- a. Hidden Leak Adjustments: Ann had prepared the final draft of the updated ordinance covering this topic. Ed Fox made a motion to adopt Ordinance No. 04-16-2015, "An Ordinance amending Ordinance No. 7-20-2005 concerning the requirements by which a customer can qualify for the District's leak adjustment program as well as defining the method by which any leak adjustment would be calculated." The motion was seconded by Kathy. Motion carried.
- b. Napoleon Water Update: No report at this time.
- c. ETC Building on RWWD Property: ETC reached an agreement with the LSPOA on placement of their equipment and no longer needs the District's land.

6. Attorney's Report: No report at this time.

7. New Business

- a. Write-Offs: None this month
- b. Correspondence: None received
- c. Upcoming Conferences / Training Classes: None at this time
- d. RWWD Property Sale Options: The question was posed whether the District should consider selling any of its property. Scott read the general requirements provided by Ann related to the process of the District selling any property. There are no current plans to sell any District owned property.

### Lake Santee Regional Waste and Water District Customers

You have the option of having your water bill payments made by automatic withdrawal from your checking or savings account. This can be for the water user accounts as well as the availability accounts. The forms may be obtained from the office or downloaded from our website. You must be logged in on the website, go to Utilities, click on the water tab and it is the last form on the list.

#### Homeowners Pumps

Your grinder pump is not a garbage disposal. The following items should not be put in your system: Glass metal, diapers, socks, rags, cloth, plastics, sanitary napkins, tampons, explosives, flammable materials, lubricating oils or grease, strong chemicals, gasoline, sand, gravel, fish scales, cleaning fluids, pesticides, herbicides and toxic chemicals. The District owns the grinder station and customers are not permitted to open the tank or control panel.



**If the red light on the electric box for your grinder pump is on, it means your pump is not working properly. During regular business hours call the office at 527-2943. After regular hours call 560-1157 if you see your light or your neighbors' light on.**

A district employee will respond promptly. Also remember, there is an ordinance that prohibits the planting of trees, flowers, shrubs or other plantings within five feet of the station to allow accessibility. In addition no plantings shall be placed on the side of the pump facing the nearest road to promote visibility of the visual alarm from the roadway. Painting of the control panel or pump tank is prohibited.

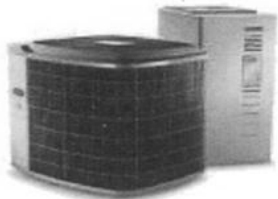

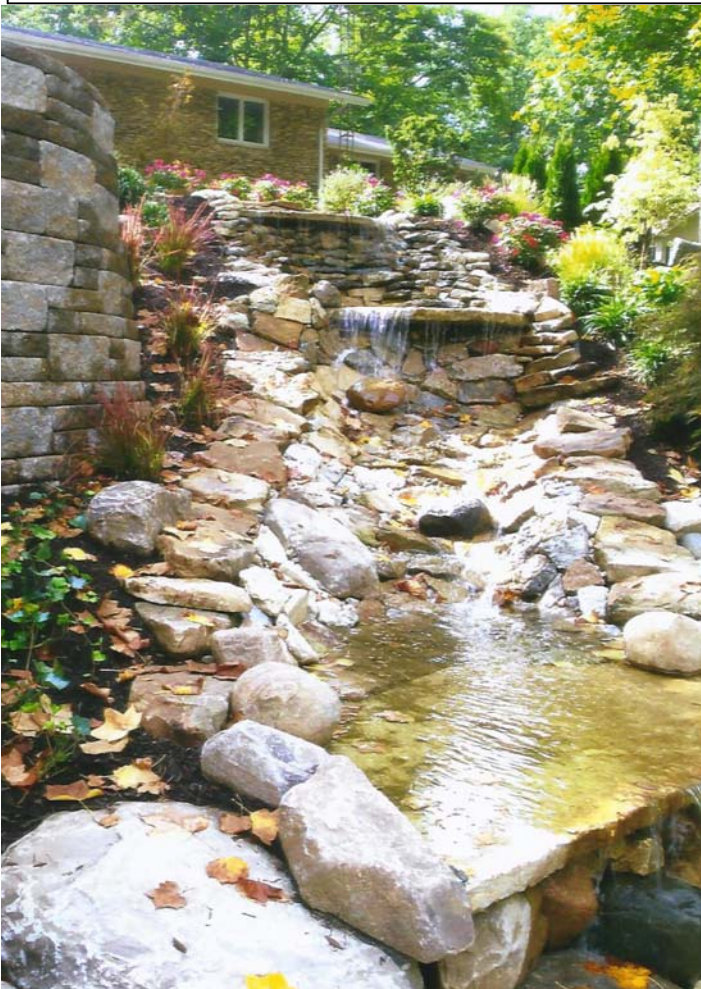

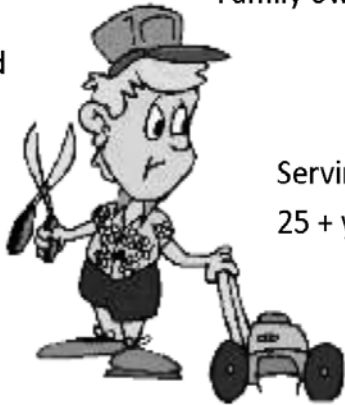
