# Water Tubing Tips: Boat Safety Tips for Water Sports Tubing

The next time you or your family decide to go out boat tubing, keep these boating safety and water sports tubing tips in mind to make sure your experience is safe and enjoyable:

- 1. Always wear a PFD**  
While it's always a good idea to wear a PFD (personal flotation device) when onboard, it should go without saying that you should wear a life jacket when water tubing. This is especially important in the event that the rider should become separated from the boat.
- 2. Know your equipment**  
Be familiar with the capabilities of your water sports tubing equipment. It's important to follow to the manufacturer's recommendations for water tubing capacity in terms of size and weight, number of riders, age limits, and maximum towing speed.
- 3. Know your rider**  
It's also important to use common sense when it comes to the capability of your rider, especially when water sports tubing with small children. While sharp turns, high speeds, and big waves can be fun, these should never come at the expense of rider safety.
- 4. Use a spotter**  
Designate one person onboard as a "spotter", who can not only keep a lookout for water tubing accidents or to see if anyone has fallen off the tube, but can also help keep the boat driver informed at all times.
- 5. Be aware of water regulations**  
Make sure you are familiar with the specific regulations governing the body of water you're boat tubing on, in particular towing speeds.
- 6. Drive Responsibly**  
The driver should be alert, sober, and have a solid grasp of boating rules and regulations. Be respectful of and keep your distance from other boats in the area when water tubing, and always keep an eye out for additional water hazards such as rocks, docks, and buoys.
- 7. Use a secure tow line**  
Another important safety aspect of water tubing, it's important to always make sure that the tow line is securely tied before take off. Also be sure to check for signs of wear, tear, and fraying, and replace as needed. Be sure to only use rope that is specifically designated for towing inflatables.
- 8. Check before you start**  
Never start the boat without first making sure that your rider is ready to go. This means that they have a firm grip on the line, are properly positioned on the tube, and that the line is properly and safely positioned. When water tubing with multiple passengers, riders should understand how to balance their weight correctly and work together to safely stay on the tube.
- 9. Handle wakes with care**  
Slow the boat speed when crossing wakes. Bouncing off wakes at extremely high speeds has been known to cause back injury, especially with riders who are water tubing stomach-down.

## Exercise caution when pulling more than one tube

It's especially important to travel at slower speeds and keep an extra careful eye out if you are boat tubing with more than one tube. Dual water sports tubing can often result in large crashes and serious accidents, should the tubes happen to collide.

To all boating members:

RE: FINE POLICY – automatic \$75 fine for boating violations first offense, \$100 fine for 2<sup>nd</sup> offense, and a Board Review for the 3<sup>rd</sup> offense.

Lake Santee is a private lake for use by members of the Association. To restrict access and maintain a safe lake, Rules & Regulations must be in place and enforced for the benefit of the members. Due to the noticeable increase in reoccurring violations by members and guests, it is apparent that verbal and written warnings are not making an adequate impression on those violating the Rules & Regulations. A decision has been made by the Board of Directors to provide for automatic monetary fines for any violation of the following Rules & Regulations:

- 4.2 All boats shall have affixed the property Owners' lot numerals, in a contrasting color, not less than three (3) inches in height. Lot numbers shall be placed in the middle of the boat on each side thereof, clearly visible to the Lake Patrol at all times.
- 4.3 All watercraft must have a current permit affixed on the port (left) and starboard (right) side of the boat near the lot number or on the left and right side windows prior to launching. Annually, upon payment of dues, assessments and fees, members shall be entitled to purchase registered boat permits, which authorize them access to Lake Santee. Permits will be available in five different classes depending on the type of boat. The Board of Directors shall determine from time to time the amount of fee to be charged for such permits.
- 4.7 From sunset to sunrise no person shall operate a watercraft without displaying lights as follows:
  - a) Motorboats and auxiliary sail boats must display a white 360 degree aft light, or a combination aft and masthead light, at all times while under power or sail,
  - b) Motorboats and auxiliary sail boats with engine rated 15 hp or greater must display red and green bow lights when under power or sail,
  - c) Boats with engines less than 15 hp or using only trolling motors must display hand lantern or flashlight (visible for two miles) or white aft light in sufficient time to avoid a collision with any other boat.
  - d) All boats when not underway are required to display a white light visible in all directions whenever they are moored or anchored away from the dock between sunset and sunrise.
- 4.8 The following restrictions shall apply to motorboats while under power. No person shall:
  - a) Sit on gunnels (sides) or railings of a boat
  - b) Dangle feet from boat
  - c) Ride forward of the safety railing on pontoon boats
  - d) Stand, sit on seat backs or move about while pulling skiers, tubers, etc.
  - e) Ride on the upper deck of a pontoon.
- 4.11 No person shall operate a power craft upon Lake Santee during daylight hours at a greater speed than is reasonable, having due regard for traffic, surface and other hazardous conditions, with no power craft to exceed the speed of 35 miles per hour. Except that on Saturdays, Sundays and holidays the speed shall not exceed 30 miles per hour. No person shall operate a power craft upon Lake Santee from dusk to sunrise at a speed greater than idle speed. The period from dusk to sunrise shall be determined by observing the red signal light located at the south end of the Lake. The yellow signal provides a warning period during which you should begin to terminate high-speed operation, skiing and related activities.
- 4.12 No person shall operate a power craft within or through the shore zone or any cove at a speed greater than 5 miles per hour or a speed that creates a wake. The shore zone means that water area of a uniform width of 100 feet lying parallel and contiguous to the shoreline. The dam shall be considered a shoreline.
- 5.1 Water skiing shall be permitted on Lake Santee from sunrise to dusk, except in the posted fishing area, beach areas and coves. The period from sunrise to dusk shall be determined by observing the green signal light located at the south end of the Lake. The yellow signal provides a warning period prior to a red signal, during which skiing and related activities shall begin to be terminated.
- 5.2 There shall never, at any time, be more than two individuals pulled by any power craft.
- 5.3 No skiing, tubing or other similar water sport activity will be permitted without two (2) occupants in the boat, one for spotter. Spotters will be eight (8) years of age or older.
- 5.4 Any skier, tuber or anyone engaging in a similar water sport must have on his person a US Coast Guard approved type I, II or III personal flotation device.

A violation of any one of the above Rules & Regulations by a member or guest will result in the member being fined \$75, \$100 for 2<sup>nd</sup> offense & a Board Review of a 3<sup>rd</sup> offense.

***Please take a few minutes to read this to keep everyone safe.***

- **Please follow all rules when on lake property.**
- **All motorized equipment needs to have proper stickers, this includes autos, watercraft and golf carts.**

# SAFETY IN AND AROUND YOUR HOME

We want everyone to have a great summer, and a safe one. Whether the weekend will involve fireworks, grilling or going to the beach, there are safety tips everyone can follow.

## **FIREWORKS SAFETY**

The safest way to enjoy fireworks is to attend a public fireworks show put on by professionals. Stay at least 500 feet away from the show. Many states outlaw most fireworks. If someone is setting fireworks off at home, they should follow these safety steps:

- Never give fireworks to small children, and always follow the instructions on the packaging.
- Keep a supply of water close by as a precaution.
- Make sure the person lighting fireworks always wears eye protection.
- Light only one firework at a time and never attempt to relight "a dud."
- Store fireworks in a cool, dry place away from children and pets.
- Never throw or point a firework toward people, animals, vehicles, structures or flammable materials.
- Leave any area immediately where untrained amateurs are using fireworks.

## **GRILLING SAFETY**

Every year people in this country are injured while using backyard charcoal or gas grills. Follow these steps to safely cook up treats for the backyard barbecue:

- Always supervise a barbecue grill when in use.
- Never grill indoors – not in your house, camper, tent, or any enclosed area.
- Make sure everyone, including the pets, stays away from the grill.
- Keep the grill out in the open, away from the house, the deck, tree branches, or anything that could catch fire.
- Use the long-handled tools especially made for cooking on the grill to keep the chef safe.
- Never add charcoal starter fluid when coals have already been ignited.
- Always follow the manufacturer's instructions when using grills.

## **BEACH SAFETY**

If someone's visit to Lake Santee includes swimming. You should know that we DO NOT have life guards on duty at any time. Other safety tips include:

- Keep alert for local weather conditions. Check to see if any warning signs or flags are posted.
- Swim sober and always swim with a buddy.
- Have young children and inexperienced swimmers wear a Coast Guard-approved life jacket.
- Protect the neck – don't dive headfirst. Walk carefully into open waters.
- Keep a close eye and constant attention on children and adults while at the beach. Wave action can cause someone to lose their footing, even in shallow water.

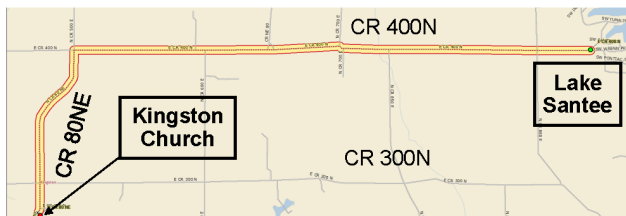

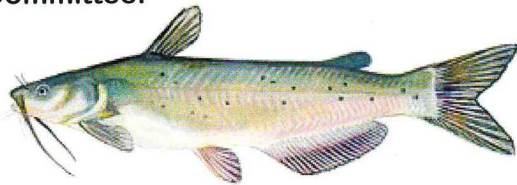

# WANTED BULLHEAD CATFISH



Lake Santee is experiencing an unwanted increase in its number of bullhead catfish. Unlike Channel Catfish, Bullheads are an undesirable fish whose size remains small, and can quickly overpopulate. Bullheads are bottom feeders that stir up bottom sediments, which can increase turbidity, and add to our water clarity issues. Channel Catfish can be easily distinguished from Bullheads by their deeply forked tail. Anglers, please remove all Bullhead Catfish that you catch. Thank you, Lake and Beaches Committee.

1. Roll Call

Vice-President Clair Fredrickson called the meeting to order and requested a roll call. Members present were Frank Erdosy, Scott Gibbs, Clair Fredrickson, Jim Hornig, Paul Gosnell, Kathy Tarzwell, and Greg Montgomery. Also in attendance were Brad Jones, Utility Administrator, Brandon Litmer, Utility Superintendent and Scott Wyatt, attorney for the District.

2. Consent Items

- a. Minutes from April 20, 2017
- b. Financial Reports
- c. Register of Claims for sewer operating
- d. Register of Claims for water operating

A motion was made by Kathy Tarzwell and seconded by Scott Gibbs to accept the consent items. Motion carried.

3. Treasurer's Report

Greg Montgomery reminded everyone to sign the forms needed to establish the new set aside accounts.

4. Superintendent's Report

- a. Sewer Status Report – Brandon Litmer reported that all is going well at the sewer plant with no issues.
- b. Water Status Report – Brandon Litmer reported that the flushing is almost done. All the rain we have had has put this behind schedule. He reported that he sent some water samples to the lab and is not anticipating any problems. The metals testing on the old carbon came back and now we are waiting to see if the land fill will accept the carbon for disposal.

5. Administrator's Report

- a. Status Report – Brad Jones reported there were 18 credit card transactions, 163 ACH's, 4 valve turns and 3 shut offs, with 1 still off.
- b. Write-Offs / Adjustments – None this month.
- c. Correspondence – Brad Jones reported that Shaun King of Sherman, Barber and Milliken submitted the year financial reports to the State Board of Accounts. The board was given an updated balance sheet. He reported that Jayhawk is raising the price on the card stock we use for our billing. We have plenty right now so will not be ordering any more at this time. Brad also reported the Quick Books software has been updated.
- d. Attorney's Report – Scott Wyatt stated we need to have another executive meeting concerning the "525" lawsuit. He also brought a resolution for our leak detection policy. Frank Erdosy asked Scott about "level billing". Scott stated that we would need an amended ordinance to do this. The board is not interested at this time.



6. Old Business

- a. Leak Detection Policy - The policy was read by Kathy Tarzwell. Jim Hornig made a motion to accept this policy and Scott Gibbs seconded. Motion carried.
- b. Jesse - Sewer license - Brandon Litmer only found a class in northern Indiana for Jesse to take. He will call the Alliance to see if they have anything.
- c. Napoleon Auxiliary Water Supply - Brandon Litmer stated he has not heard anything on the signing of the easements. He will talk to Gene Eaton soon.

- e. Water Tower Exterior Epoxy Overcoat & Foundation Repair - Since the Epoxy Overcoat is so expensive we need to take bids on this. Brandon Litmer is going to talk to Dixon Engineering for the specs for a bid package. He will also ask them to recommend what project needs to be done first with the tower.
- f. Water Tower Security - Scott Wyatt is going to look at the building codes to see if we could put up concrete barriers around the water tower without a bid process.. Brandon Litmer has gotten some prices and he is going to check to see if delivery is included.
- g. Outdated Policies - Clair Fredrickson - Scott Wyatt stated that we need to make only one resolution to identify those no longer in effect. Then store in permanent file storage.
- h. Lawsuit "525" - There will be an Executive Meeting held on May 25, 2017 at 5 o'clock with a Special Meeting immediately following.

After presentation, the bills were approved for payment on a motion by Carol Goodwin, seconded by Dave Martin.

## MEMBER INTRODUCTIONS AND COMMENTS

Members were asked to introduce themselves and were given the opportunity to express comments.

Paul Gosnell spoke on behalf of the Lake Santee Booster Club and stated the project started last summer to help beautify the outside of the building is now complete with the addition of lights to the posts on the deck.

Members mentioned/asked the following:

- When will the lignin be spread on the gravel roads?
  - Polly stated she needed to confirm with Brandon but the goal is to have it down prior to the July 1<sup>st</sup> festivities.
- A member asked if it was possible to change the rule on allowing tents even if it was just to homeowners or allowed for two days.
  - The rule in regards to not allowing tents is a part of the land restrictions for the community. The land restrictions are extremely difficult to change, as they require the majority of the membership to vote in favor.



- It was also brought up that there is a violent sexual predator living within the subdivision and if there was anything we could do to prevent this. The member also asked if there was a way to be notified if a sex offender moved into the subdivision.
  - If you go to the Indiana Decatur County Sheriff Department's website you can input your address to view any sexual offenders in your area. There is also an option to sign up for alerts. It was stated that you could also alert your neighbors.
  - As far as limiting who lives within our community we can't, as that would be considered discrimination. The Board stated they had talked with the prosecutor along with our attorney to determine if there was a way to limit access to areas where children might be such as the beach. It was determined since lake property is considered private and not public, there was nothing the Board could do to enforce the normal distance that is required for say a city park.
- A concern was brought up in regards to the cloth benches located on the beach as they are coated in bird droppings. The member stated this is a huge health hazard and asked that the benches be removed.
  - The Board stated they would have maintenance take a look at them.
- A member brought up a concern with speeding in the vicinity of Choctaw and the north entrance. The excessive speeding is causing unnecessary dust from the gravel roads and a danger to walkers/runners. The member asked security to try and catch the person causing the most problems.
  - Security stated that they've been trying to catch the individual on radar but so far have been unsuccessful. President Day asked Brad since we know whom the member is to send a letter asking them to slow down.
- There is a concern with the beach restrooms on weekends not being stocked fully with toilet paper and soap.
  - If you notice an issue with the restrooms please call the Maintenance on call number located in the Smoke Signals so the issue could be addressed.
- A member stated that they've noticed an increase in dead fish, goose droppings, trash, and bottles on both beaches the last few weeks and asked how frequently the beach is being cleaned.
  - President Day stated we did have a small fish kill in the last few weeks that has caused dead fish to wash ashore. Maintenance has tried cleaning up the fish on the beaches and lake access areas.
  - The beach is cleaned on Friday's and Monday's each week.
- Another member reiterated the issue with goose droppings and health concerns and asked if we could do anything to help eliminate them.

- It was stated that we have oiled the eggs in years past as well as have a controlled hunt during season.
- There was also a concern with dogs being walked and owners not picking up after them.
  - Please be courteous of your neighbors and pick up after your pets.

## **CORRESPONDENCE**

Brad stated he received two letters against the proposed change of rule 4.1.

He also received a letter from a concerned member in regards to a drone being flown around the main beach area. The letter stated the member was at the beach with a child and a drone was flying around the area and kept hovering above them. The member expressed the thought of pictures or videos that could have been taken of them were disturbing. The member stated they would like to see us require a license issued by the FFA to operate a drone in our subdivision. We could also possibly treat the drones as we do boats and golf carts and require a permit to operate them.

A letter was also received from Jody Coffman with Decatur County Memorial Hospital. Jody is on the committee for the Decatur County Memorial Hospital 5k and would like to request permission for a Thanksgiving Day 5K. Jody was previously employed with Anytime Fitness and helped organize the previous Dam Thanksgiving Day Race in 2013-2014. With the help of Decatur County Hospital Jody would like to bring back the race to Lake Santee this year. The race would be November 23<sup>rd</sup> 2017 and would start at 8am. They would like to request the use of the Community Room for use as a pre-race station and the race would end no later than 10am. Jody stated in her letter that Brad Speer with the Clarksburg Community Volunteer Fire Department is willing to coordinate emergency services for the event.

A motion was made by Carol Goodwin to approve the request, motion seconded by Dave Martin. Motion carried.

## **COMMITTEE REPORTS**

### **Rules & Regulations – Angel Hocker**

Angel started by stating the reason for the proposed change to rule 4.1 was primarily caused by the issue with swim platforms being included with the titled length of the boat. Since the platform does not create a larger wake the Board originally thought it would help eliminate some confusion and issues. Each Board member received numerous calls



both for and against the proposed change. At this time the Board would like to table the rule change until there is a full board that can fully address all possible concerns and issues with the matter. A motion was made by Polly Ann Fox to table the proposed change until further notice; motion was seconded by Carol Goodwin. Motion carried.

Angel then asked for members to express any concerns or input they might have and the following was discussed:

- Boats traveling at night with no lights or driving at night with a wake.
- Boats not adhering to Rule 4.2 - 100 ft from shoreline.
- Lifejackets on paddleboards
  - Security will continue to check paddleboards and kayaks for lifejackets.
- Limit restrictions of boats and speed allowed. – A member brought up the example of tri-tunes with large motors doing tight circles while pulling tubers.
- Issue with waves from wake setter boat pushing a fishing boat into the shore
- Lack of education on boats, how boats are titled could help with confusion in office of what is a speed or ski boat vs. deck boat. Manufacturers website should list what type of boat it is considered.
- A member against increasing the length of any boats also stated that boating manufactures state wake setter boats should be at least 300 ft. from shoreline and provided a map showing the small area towards the south end of the lake that is wide enough to meet the recommended criteria.
- Member stated there was a near drowning last weekend at the main beach with a young child getting knocked over by a wave that came into the beach area. The child lost their footing and panicked.
- Member stated their concern the lake is not large enough for wake boarding and would like to see a rule passed to eliminate or provide restrictions.
- Member stated there has been recent area lake related accidents reported in the media including a boating accident at Brookville, a drowning at Hidden Valley, a boating accident at Shafer Lake and a drowning related to a paddle board in Fishers.
- Member stated she would like to see us require members to watch a boat safety video that was created last year.
- It was brought up that we have a large variety of demographics and how people want to spend their time on the water – skiing, wakeboarding, tubing, fishing, etc and if there were going to be rules in place for one there really should be rules in place for all. With the size of the lake we all need to be cautious and stay the appropriate distance from other boats (especially wake setters). Lake Santee typically has smooth water through out the week. Rough water is not ideal for skiing or wakeboarding, which is a reason people, are learning to wake surf. It

was brought up that some lakes don't allow vertical seawalls as when the waves hit them they are directed back out into the main body of water.

### **Recreation – Carol Goodwin**

Carol stated on July 1<sup>st</sup> the Women's Club would be holding their annual bake sale and merchandise sale in the community room. The Clarksburg Volunteer Fire Department will be having a BBQ lunch. A Beach Bash with games sponsored by MainSource Bank will be held from 2-4 at the main beach. The youth fishing tournament will be on Sunday July 2<sup>nd</sup> and pre-registration is highly encouraged.

The Euchre club will be meeting every other Thursday opposite of the Trivia Night at Dockside Bar and Grille. Carol thanked Buddy and Terri Suiters for their assistance. The first movie night will be on June 24<sup>th</sup>.

Carol has received quotes for the projector and speakers for the amphitheater. Carol made a motion to purchase the equipment from Ovation with a quote of \$5,000. The motion was seconded by Polly Ann Fox. Motion carried.

Carol stated while cleaning out the closet in the Community Room she located some shuffleboard equipment. The equipment can be checked out by contacting the office.

### **Lakes & Beaches – David Martin**

Dave started by saying the dredging has been finished. The boat docks are due to be installed on Friday (6/16). The goal is to have the dirt removed prior to the July 1<sup>st</sup> weekend. The removal of the dirt is estimated to take 3 days. Once the docks are in place if you have a reserved slip you are welcome to start using it. Please keep in mind it could be dusty or muddy until the new grass takes off. It was also requested that golf carts remain off the area since new grass will be planted.
