## Smoke Alarm Safety

Smoke alarms can act as a warning to get out of a building when a fire occurs, but they are only effective when working properly. Every home and business should be equipped with smoke alarms that are installed correctly and tested regularly.

The right way to install smoke alarms:

- Install smoke alarms on every level of your home, including the basement, making sure there is an alarm outside every separate sleeping area. New homes are required to have a smoke alarm in every sleeping room and all smoke alarms must be interconnected.
- Hard-wired smoke alarms operate on your household electrical current. They can be interconnected so that every alarm sounds regardless of the fire's location. This is an advantage in early warning, because it gives occupants extra time to escape if they are in one part of the home and a fire breaks out in another part. Alarms that are hard-wired should have battery backups in case of a power outage, and should be installed by a qualified electrician.
- If you sleep with bedroom doors closed, have a qualified electrician install interconnected smoke alarms in each room so that when one alarm sounds, they all sound.
- If you or someone in your home is hearing impaired, consider installing an alarm that combines flashing lights, vibration, and/or sound.
- Mount smoke alarms high on walls or ceilings (remember, smoke rises). Ceiling-mounted alarms should be installed at least four inches away from the nearest wall; wall-mounted alarms should be installed four to 12 inches away from the ceiling.
- If you have ceilings that are pitched, install the alarm near the ceiling's highest point.
- Don't install smoke alarms near windows, doors, or ducts where drafts might interfere with their operation.
- Never paint smoke alarms. Paint, or other decorations could keep the alarms from working.

A life-saving test: check your smoke alarms regularly:

- Test your smoke alarms once a month, following the manufacturer's instructions.
- Replace the batteries in your smoke alarm once a year, or as soon as the alarm "chirps" warning that the battery is low. Hint: schedule battery replacements for the same day you change your clocks from daylight savings time to standard time in the fall.
- Don't disable smoke alarms even temporarily. If your smoke alarm is sounding "nuisance alarms," try relocating it farther from kitchens or bathrooms, where cooking fumes and steam can cause the alarm to sound.
- Regularly vacuuming or dusting your smoke alarms can keep them working properly. Be sure to follow the manufacturer's instructions.
- Smoke alarms don't last forever. Replace yours once every 10 years. If you can't remember how old the alarm is, then it's probably time for a new one.
- Consider installing smoke alarms with "long-life" (10-year) batteries.
- Plan regular fire drills to ensure that everyone knows exactly what to do when the smoke alarm sounds. Hold a drill at night to make sure that family members awaken at the sound of the alarm.
- If you are building a new home or remodeling your existing home, consider installing an automatic home fire sprinkler system. Sprinklers and smoke alarms together cut your risk of dying in a home fire by 82 percent – a savings of thousands of lives a year.

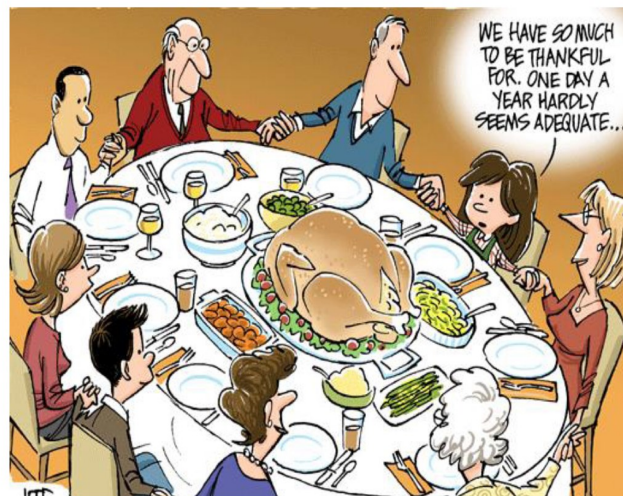

Editors note: In the past few weeks our Totem Pole has been refurbished and repainted. The responsibility of this on going program is a project sponsored by the Women’s Club. Since our Totem Pole is now associated by many outside of our community as being a part of Lake Santee, we thought it was a good time to reprint the following story of our now famous landmark.

## **Totem Pole Trivia** by Nancy Fredrickson

Lake Santee Women’s Club had a vision 16 years ago that they would like to have a new Totem Pole at the entrance to the lake. With the LSPOA board’s permission they began to study Totem Poles. Some of our members had seen the beautiful carvings done by Red Hawkins, and a group of us met with Red in town to discuss our project. Red agreed to carve our Totem Pole, and he gave us the challenge to find a Catalpa Tree with at least 30 feet of straight trunk. The entire community joined in the search for such a tree, but every one we found branched too near the ground. Red came to our rescue because he had located a suitable Catalpa Tree on the farm of his friend, Dave York.

On July 20, 1998, Pat & Keith Burgess and Nancy & Clair Fredrickson were to meet Red in town to drive to the tree farm. Darrow McCreary, Lake Manager, called Nancy early that morning to tell her to hurry because our current Totem Pole had been hit by lightning the night before. Arriving at the farm, our chosen tree was about 80 years old and growing in a grove of trees that had been planted for fence posts. It was 70 feet tall, no branches for at least 30 feet, and straight as an arrow (or Totem Pole). It was beautiful! Paul Hughes of Hughes Tree Service, cut down the tree and cut off the branches, donating his services which we really appreciated. We had the tree moved to Red’s Buggy Bath on Main Street.



**The “Barking Party”**

On August 3, many Women’s Club members and their husbands joined us for what became known as the famous “Barking Party” to remove the bark from our Catalpa tree. The tree then had to age for 6 months.

During this time, the Women’s Club members had to decide what we wanted carved on our Totem Pole. We studied books, talked to Red Hawkins, our carver, and thought of symbols that represented our love for Lake Santee. Barb Hickey, the artist in our group, helped us draw them in a pleasing order on a long strip of brown paper, which I still treasure. Red was a big help on the details of our drawing, and we gave him artistic license to make changes as he saw fit. In October we had agreed on final plans, and we moved our tree to Red’s home at Lake McCoy. Red built a shelter in his yard and covered it with plastic so he could have a heater inside to keep him warm as he carved.

Red began carving in February, and we were excited to see the beginnings of his carving on March 2<sup>nd</sup>. Each time we went to see it we were thrilled to see how he had taken our sketches and transformed them into a work of art. Red finished carving about



May 1<sup>st</sup>, and on May 10<sup>th</sup> we moved our Totem Pole a 3<sup>rd</sup> time – to our new Lake Santee maintenance building.

Barb and Dick Hickey were in charge of staining the Totem Pole, and they purchased penetrating finish that Jean & Company tinted in the colors we had selected. The week of May 10-15 we donned our best clothes, and tried to stay out of Tom Crowe’s way as we stained and sealed our Totem Pole. With Red’s detailed carving, and Barb and Dick’s colored plan and their artistic guidance, it was almost like paint by number. Our stainers were Barb & Dick Hickey, Connie Barnes, Pat Burgess, Rilla Denton and Nancy Fredrickson.

At this point we turned the project over to Tom Crowe, Darrow McCreary, Harold Cooke, and the maintenance crew. A few things they had to figure out were: how to reinforce the pole to keep it from splitting, how deep the concrete needed to be, how to mount it so that there would be an air space between the wood and the concrete so the pole would not wick moisture from the concrete, how to lift the pole into place, and how to level it once it was in position. The week of June 7th, they dug the hole and poured the concrete. Tom’s final challenge came on June 22 when he brought in a boom truck and he and his crew skillfully and successfully put our Totem Pole in place.

front page of the paper the next day!

In July Lake Santee Women’s Club hired Roger Locke of Custom Wood Signs to make a sign for our entrance. Fortunately, the maintenance team actually installed the sign, not us.



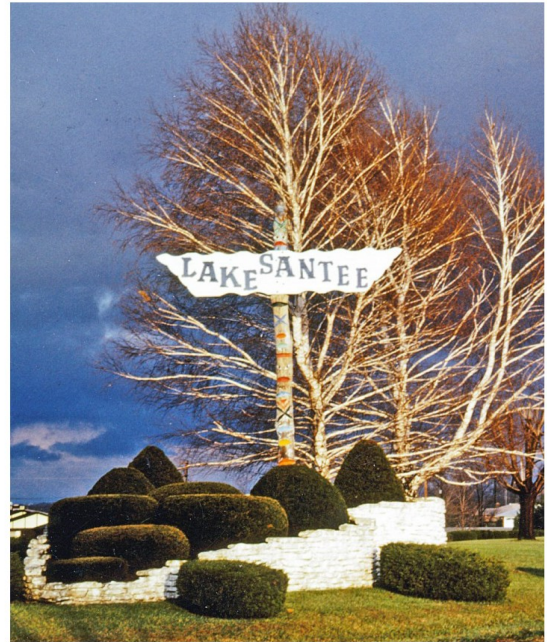


Our Totem Pole Dedication was held on July 24, 1999. We had invited everyone who had helped with the project as well as LSPOA employees and board members. Women's Club also sponsored a Caribe Steel Band concert on the following afternoon as a celebration.



Presiding over the ceremony were Nancy Fredrickson, president when the project began, and Connie Barnes, president during the 2nd half of the totem pole construction. Red Hawkins was honored as he proudly carved his name on his totem creation.

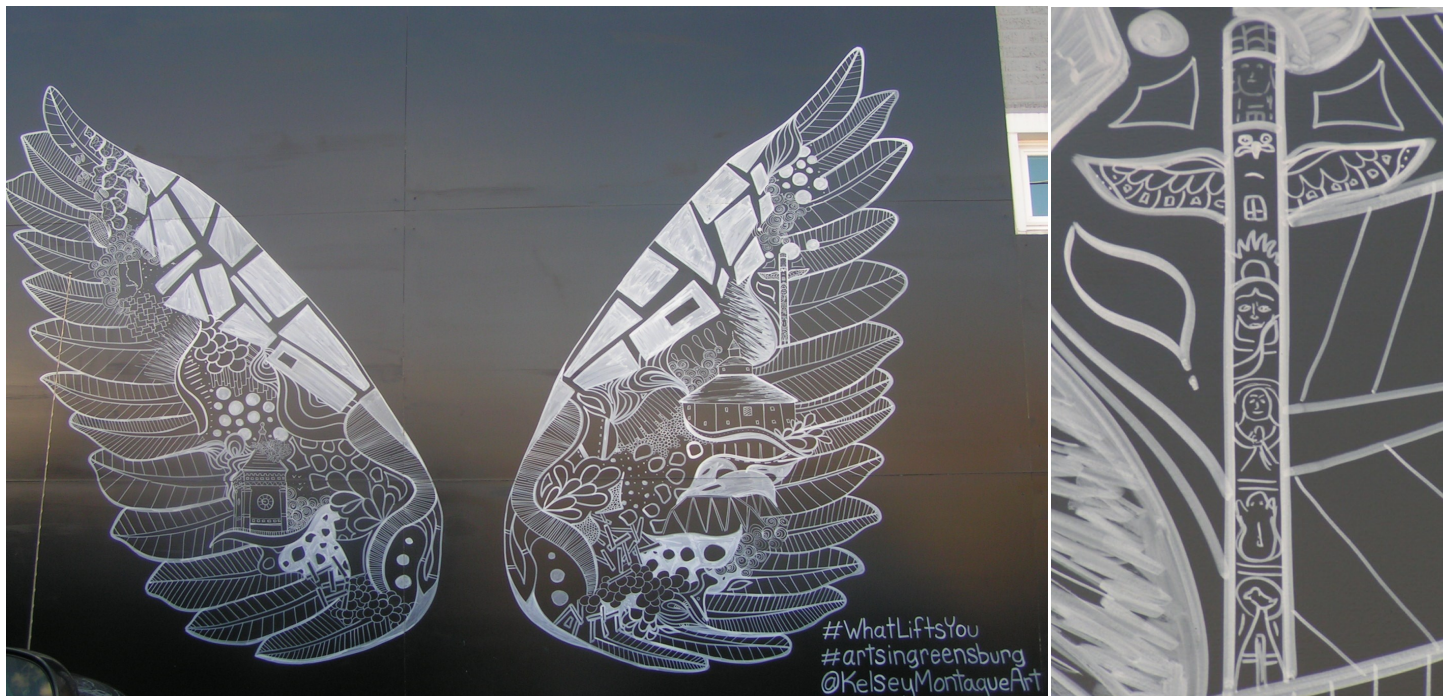

3. Superintendent's Report

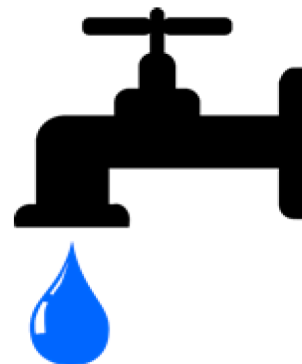

5. Attorney’s Report – None this month.

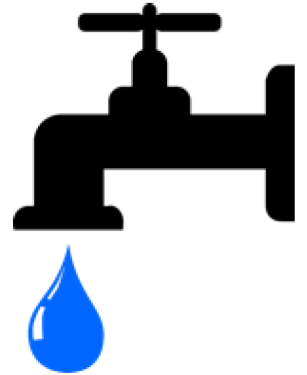
6. Old Business

# WATER TOWER WORK COMPLETED IN OCTOBER

## Tower Repair Project

The tower project has been completed. The inspector from Dixon Engineering was pleased with the contractors work. Overall I was pleased with the contractor and enjoyed working with them. The following is a list of everything the contractor completed.

---

The wet interior roof hatch was removed and replaced with a larger 30" diameter hinged hatch.

The access tube roof hatch was removed and replaced with a larger 30" diameter hinged hatch.

The condensate platform hatch located on the interior of the tower at the base of the tank bowl was removed and replaced with a larger 30" diameter hinged hatch. All of these hatches needed to be replaced to be in compliance with the current OSHA standards.

An aluminum jacket was added over the insulation that covers the tower fill pipe that runs from the base of the tower up to the tank. The aluminum jacket was added because the previous paper jacket was falling off exposing the insulation.

A mud valve was added at the base of the tower bowl. The mud valve is used when the tank is drained for cleaning. It is located at the very bottom of the tank bowl and is connected to the tank overflow pipe. The valve is opened to allowed the water to drain out while the tank is being cleaned.

A rail type fall prevention device was added to the ladder on the interior of the tank bowl. Previously there wasn't any fall prevention device on the ladder.

A painters rail was added outside of the existing handrail on the roof of the tower.

A rigging lug was added above the top platform ladder on the interior of the tower. A rescue cable can be connected to the lug in the event of an emergency where someone needs to be lower to the base of the tower.

The concrete foundation of the tower was repaired with patching mortar. There was some deterioration of the concrete on the exterior of the tower base. The deterioration was minor and the foundation overall is in good condition. The foundation was coat with a two part epoxy paint once repairs where completed.

Lighting fixtures were added on the interior of the tower from the base to the roof. Previously there was only one light fixture located at the base of the tower.

An automatic controlled cathodic protection system was installed to prevent corrosion on the submerged interior of the water storage tank. Corrpro is the company that installed the system. Once the tank is full they will start the system and check for proper operation.

A three coat epoxy urethane overcoat was applied to the entire exterior of the tower. The tower was pressure washed at 10,000 PSI prior to the overcoat.

The meeting was paused to allow Shawn Matthews with Decatur County REMC to present information on the Decatur County REMC right of way program. MEMBER INTRODUCTIONS AND COMMENTS

Members were asked to introduce themselves and were given the opportunity to express comments.

- Two members spoke in regards to lignin not being put down on all gravel roads in the subdivision. Both were disappointed as this helps control a great deal of the dust that gets on their vehicles and golf carts. They asked for a higher priority for this to be completed sooner and all around the lake next year.
- Another member spoke in regards to needing more boat slips available for members next year and that they hoped the board would budget for more. This member also talked about the need for a flashing light at the intersection of 400N and 880E. She has been in contact with the Decatur County Highway Department.

COMMITTEE REPORTS

Rules & Regulations – Angel Hocker

Angel started by thanking the board for their hard work and looking into the issues the membership has brought up. She informed those in attendance that the board had held an executive session to discuss rule changes. The board determined it was best to slowly make changes as needed. Angel presented the following rule changes for Rule 4.1 and 4.5.

Rule 4.1

Only one boat of each type available is allowed on the Lake per membership. For example only one speed, pontoon, sail, bass and motorized fishing boat will be permitted. A deck boat may be substituted for either a speed or pontoon boat. In addition the member may have a canoe, rowboat, paddle boat, raft, etc. The length of speed, bass & fishing boats shall not exceed 20 feet. Deck boats are not to exceed 22.5 feet. Pontoon boats are not to exceed 28 feet. No watercraft with sleeping or on board toilet facilities will be permitted. Wake enlarging equipment (ballast, mechanical blades, etc.) will be limited to boats 20 feet in length and under.

a) Paddle Boards will be considered a watercraft and will comply with all boating rules included in this boating section. Members may have up to six paddle boards in addition to the boats and watercraft listed above. Paddle boards will only require a single set of lot numbers and will only display one permit.

Rule 4.5

No person shall operate a boat on Lake Santee unless said boat is owned by a member of the Association. Proof of Ownership shall be by state registration and/or certificate of title, which will be shown before a permit is issued for any motorboat (as defined by Indiana State Law).

a) Members shall certify that they are financially responsible or have liability insurance at the time permits are issued.

b) Effective January 1, 2018 for boats that do not already have a copy of title or registration on file in the office, manufacturer specifications will be confirmed by office staff to ensure compliance with rule 4.1. Items confirmed by specifications may include, but are not limited to, length, type and options available.

A motion was made by Doug Lecher to accept the proposed rule change to 4.1 and 4.5 as read. Dave Martin provided a second. President Day asked for a roll call vote with all members voting in favor. Motion Carried.

A member in the audience brought up a concern in regards to how boats are being classified as deck boats. Doug Lecher gave a clarification that going forward the

LSPOA office would look up manufacturer specifications to confirm that a boat is specifically classified as a deck boat.

Recreation – Carol Goodwin

Carol started by saying Euchre will be continued through October and is every other Thursday.

- Trick or Treat & Trunk or Treat will be October 28th from 5:30-7:30. Please turn on your light if you wish to have people at your home or join in the fun at the parking lot at the main beach.
- Holiday lighting contest will be December 9th.
- Breakfast with Santa – A date has not been chosen as Carol is still waiting to hear back if the Kiwanis Club will be doing breakfast. Ronda Peetz stated if the Kiwanis were not able to do the breakfast Tree City Properties Inc. would be happy to provide doughnuts for the event.
- Volunteers are needed to assist with all of the fun activities recreation has started planning for next year. Contact Carol to volunteer.
- Christmas with the Birds will be December 2nd from 10am-noon in the Community Room.
- It was discussed if we should have the 4th of July festivities on June 30 or July 7th next year. Brad will get with the fireworks vendor to check availability.

Lakes & Beaches – David Martin

Dave stated he has met with a Goose Control Expert and he stated there was nothing he could do to assist with keeping the geese off the beach, however, he did have a suggestion to try. We could try to install some fencing on the beach at the waters edge during non-boating months. This would a trial and error to determine if it would help. Dave also thanked Polly for allowing the use of her budget to purchase some sand for the East Beach.

Steve stated the clean up committee sent out four first letters, one second letter, one fourth letter, and one thank you. We have three properties on the watch list. One property is being fined and another property with a building permit receiving a fine.

Roads & Maintenance – Polly Fox

Polly started by stating the North Entrance has been paved and the third speed bump was installed today. Maintenance has started on Lot 137 and almost has it complete. They need some larger rip rap to finish the project. Maintenance will be doing some grading of the roads. The Seneca mailbox cluster has been completed. They are working on getting some more approvals on the remaining mailbox clusters. Three truckloads of sand has been delivered to the East Beach and needs spread. The lowering of the lake will start on October 13th. It will be lowered a minimum of 3ft. Dave stated it would be best to lower it to at least 5ft to help with the gizzard shad.

Security – Wade Amos

Wade stated we are working on getting quotes for a new radar gun for the security vehicle. He is also working on getting quotes for new security cameras for various locations around the lake. Wade mentioned the need to focus on the many safety concerns for our membership and that Security has a responsibility to the members of the lake.

A question was brought up in regards to the new sign at the North Entrance prohibiting heavy trucks and if the sign should have said no commercial vehicles. It was also brought up by a member that maybe we should check with O'Mara Paving to see what the load limit is and maybe add a sign stating the limit for the road.

OLD BUSINESS

O'Mara Paving – Ron stated at the last board meeting he did not ask for formal board approval to accept the bid from O'Mara Paving. He was previously concerned that we needed to get placed on O'Mara's list to ensure they were able to get the paving completed this fall. They had a cancellation and got to us quicker than expected. At that time Ron asked to accept the low bid from O'Mara for \$21,850 to pave the north

entrance. A higher bid was received by Wingham's for \$28,900. A motion was made by Angel Hocker to accept the lower bid and seconded by Carol Goodwin. Motion carried.

NEW BUSINESS

Tax Sale – Brad asked for permission to attend the Decatur County tax sale on October 26th. When the notice was originally placed there was 13 properties at Lake Santee up for sale. The list is now down to 9. The starting bid for the properties is \$2,230.32. A motion was made by Carol Goodwin to bid up to \$3,000 for these properties. The motion was seconded by Polly Ann Fox. Motion Carried.

Equipment Trade with Lake Santee RWWD – Ron stated he was approached by Frank Erodsy the RWWD Board President to complete an equipment trade. Frank stated the State Board of Accounts does not like them to hold equipment on their books that they are not utilizing and suggested we do a trade on some of the equipment. The Lake Santee RWWD had advertised as they are required a notice of intent to exchange property.

The Lake Santee RWWD currently owns a 2001 John Deere 7810 tractor as well as a 2000 John Deere 6x4 DSL Gator and intends to exchange that property for a 2010 John Deere 310SJ Backhoe owned by Lake Santee POA.

MANAGER'S REPORT

Brad stated the office collected \$1,500 in bad debt and the member still owes \$1,000 and should be collected soon. He has made progress on getting a member only section on the website and expects to have financials up soon.

We are working on getting a communications alert system that will allow the office to send out a notification via email or a text if something happens at the lake. More details to come on this as we get the system tested.

There being no further business, Doug Lecher moved to adjourn, seconded by Polly Ann Fox, motion carried. The next regular meeting will be held on November 8, 2017 at 7:30pm in the Community Room.
